- Objectives
 - Look into Dr. Samuel MEISELS, Buffet Early Childhood Institute from Nebraska
 - o What about multiple conferences throughout the year?
 - Probably not a possibility due to funding.
 - Might look into doing a statewide summit and then hold regional summits.
 - o What about a survey to mental health professionals?
 - Asking someone what they want to learn about and not know what is available might not work as well as we think.
 - Share what we have been working on
 - Possibly have Mental Health Association sponsor and discuss progress.
 - Discuss Mental Health Consultation, Competency, and Workforce Development
 - o Do we want feedback?
 - To get feedback, the small group discussions would be able to provide the feedback.
 - o Venue
 - Free space or low cost.
 - Keeping in Mid-Missouri.
 - Possible locations Schools/Universities, Churches, Hotels, State Buildings (May not have big enough spaces) – Looking for an auditorium or gymnasium for a large group.
