The Goal of Adoption and Guardianship Subsidy

In accordance with the Adoption and Safe Families Act of 1997, the Children's Division believes every child has the right to a stable and permanent family. Adoption or guardianship by a qualified family or individual is the desired outcome for children who cannot be reunified with their families. Subsidy services are available to support families adopting or obtaining guardianship of these children.

Qualified relatives are any grandparent, aunt, uncle, adult sibling of the child or adult first cousin of the child, or any other person related to the child by blood or affinity. A close nonrelated person is any nonrelated person whose life is so intermingled with the child such that the relationship is similar to a family relationship.

What is Subsidy?

Subsidy is a collaborative agreement between the Children's Division and the adoptive or guardianship family to meet the needs of the child. Financial, medical, childcare and nonrecurring expenses are available to the family through subsidy. All subsidy agreements may continue until the child is age 18. In the case of adoption youth with a documented physical, dental or mental need approval may be given for services to continue to age 21 using an 18+ agreement.

If the family adopting or obtaining guardianship of a child requests assistance, the following basic services are available:

Monthly Maintenance: Monthly payments, which cannot exceed the rate, which would have been paid if the child had remained in out of home care.

MO HealthNet: Payment for medical, dental or mental health care may be obtained through the MO HealthNet program as the primary payment or as a supplement to the families' private medical or dental insurance plan when available.

Child Care Payments for Children to Age 13: Child care may be approved at the state contracted rate to age 13 when there is a valid need. Payment may only be made to licensed/contracted or registered providers

Respite: Periodic and temporary substitute care of children designed to provide relief for the provider from the stresses of constant responsibilities. Respite should be used to maintain stable placement and not used as regular child care.

Nonrecurring Legal Expenses: Includes attorney's fees, court costs, publication expenses, and Guardian Ad Litem (GAL) costs in adoption or the guardianship case filed in a court of competent jurisdiction.

Additional services may be available based on the individual needs of the child such as:

- ◆ Nonrecurring expenses related to the child's placement
- ◆ Treatment Services;
- ◆ Crisis intervention
- ◆ Rehabilitation services

The Division cannot make payment for services that are a duplication of services provided by another resource and available to the family.

Child Eligibility

Children must be under the age of 18 and in the custody of the Children's Division, Division of Youth Services, Department of Mental Health, or a licensed child placing agency. Children in the custody of the Children's Division are automatically eligible for subsidy services. In the case of children in the custody of agencies other than the Children's Division other special needs requirements also apply as indicated in 13 CSR 40-38.

Successor Legal Guardian: Planning a Future for Your Guardian Child

As the legal guardian, you will be responsible for the care and wellbeing of the child. Naming a successor guardian at the time of guardianship planning is a critical step to ensuring the child will have someone to care for them if you are unable due to an illness or other life threatening event.

Family Resource Centers

Missouri adoptive, foster, kinship and guardian parents have the benefit of having Family Resource Center (FRC) services available through Foster & Adoptive Care Coalition, Central Missouri Foster Care and Adoption Association, and Fosteradopt Connect. The purpose for these centers is the prevention of adoption disruption and support to resource families. The centers create and utilize local and regional partnerships with other agencies providing similar services to maximize the resources available and avoid duplication or gaps in services.
