SUBJECT: RESIDENTIAL RATE INCREASE

DISCUSSION:

This memorandum is being written to alert staff to the changes in residential rates beginning July 1, 2013, as well as the requirement that subsidy contracts containing residential services be updated immediately to reflect the rate change.

Case managers are required to ensure that the Rehab start dates and CSPI scores are entered on any child/youth who have been placed in Residential care through Adoption or Guardianship subsidy.
