Welcome/Announcements: Lisa Clements, Ph.D., Clinical Director of the Psychology/Counseling Program called the meeting to order at 10:00 a.m. Dr. Clements announced the resignation of Judy Coy, LPC, from the committee and asked committee members to make suggestion for a replacement. Becky West announced MO HealthNet training workshops available free of charge to go over policy and billing information and documentation requirements. Review of Minutes: The minutes of the November 4, 2010 meeting were reviewed and approved by email on March 21, 2011.

Program Update

Web Page: Becky West gave a brief tutorial to committee members to access member information, previous meeting information, MO HealthNet trainings, and announcements on the MO HealthNet webpage.

Cyber access: The Cyber access Precertification screen format will be changing. Cyber implementation of Psychology/Counseling Precertification is in progress with weekly meetings to finalize and implement the program.

Smoking Cessation Bulletin: The bulletin for smoking cessation for pregnant women is now on the MHD web site. The program was recently expanded to include all MHD-

eligible participants and a bulletin will be posted soon. This service is available to all Managed Care Members through fee-for-service.

Autism: Pamphlets were distributed to Committee members. There was discussion regarding MHD coverage of Autism specific services. There was a request to have Dr. Terri Rodgers come to the May meeting to give a brief overview of Autism services in the schools.

Children in Foster Care: Reports were reviewed. The reports have remained consistent and continue to show the greatest utilization of PAs were for the 16 year old age group. License Provisional Counselor is still the main provider group with a significant increase in 2009. The information for 2010 was presented through a slide show with graphs depicting utilization. The committee members indicated they prefer this method for future reporting versus the written reports. The committee had a brief discussion about Trauma Informed Care. (See Handouts for the reports).

Review of Current Utilization: Discussed reports handed out. There has not been a significant increase or decrease in the totals for adults or children. The ADHD/ADD report was also reviewed with no significant changes noted.
