Setting & Population

Approval Criteria

Prescriber criteria:

• Attending physician can attest to caregiver ability to properly use monitor.

Plus one of the following criteria:

- Infant is technology dependent and supporting documentation or patient record indicates that monitor is still being used, OR
- o Infant is non-technology dependent and patient record documents a clinically significant apneic or bradycardiac episode has occurred in the last 2 months.

In addition, any one of the following criteria:

- An infant who has experienced an apparent life threatening event requiring CPR or vigorous stimulation.
- Symptomatic preterm infant undergoing medical management of apnea.
- Infant requires home oxygen therapy.
- Infant who requires less than 24 hours of continuous ventilatory support.
- Infant with a tracheotomy. (Technology dependent)
- Infant is a sibling of one or more sudden infant death syndrome victims.
- Infant has an anatomic abnormality which causes a compromise to airway.
- Infant has gastroesophageal reflux, neurologic, or metabolic disorder that affects respiratory control.
- Infant has a chronic lung disease which requires supplemental oxygen.

Supplier criteria:

All criteria must be met:

- Caregivers have education regarding mechanical aspect of monitor.
- 24 hour monitor service staff is available.

Denial Criteria

Will be denied if any of the approval criteria is not met.

Appendix A: Possible Step 1 and Step 2 Questions

**The following questions may be encountered as part of the approval and denial criteria. Depending on the patient's history and the way previous questions may be answered, not every question may be asked for every patient and may not be encountered in the exact order below.

- 1. Can attending physician attest to caregivers capability of proper use of monitor?
- 2. Is patient technology dependent?

- 3. Does patient record or supportive evidence note monitor is still being used?
- 4. Is patient non-technology dependent?
- 5. Does patient record document a clinically significant apneic or bradycardia episode in the last 2 months?
- 6. Does patient record document an infant who has experienced an apparent life threatening event requiring CPR or vigorous stimulation?
- 7. Does patient record document a symptomatic preterm infant with medical management of apnea?
- 8. Does patient require invasive ventilatory support?
- 9. Is use less than 24 hours per day?
- 10. Does patient record document an infant who requires home oxygen therapy?
- 11. Is this a tracheotomized infant?
- 12. Does patient record document anatomic abnormality which causes a compromise to airway?
- 13. What is the duration of need?_____
- 14. Is the patient below the age of death of the sibling who died of SIDS?
- 15. Does patient record document patient is a sibling of one or more sudden infant death syndrome victims?
- 16. Does patient record document gastroesophageal reflux, neurologic, or metabolic disorder that affects respiratory control?
- 17. Does patient record document a chronic lung disease which requires supplemental O2?
- 18. Have caregivers had education regarding the mechanical aspect of the monitor?
- 19. Is there 24 hour monitor service staff?
