- **RATE UPDATE FOR HOME AND COMMUNITY BASED SERVICES**

MAXIMUM ALLOWABLE RATE DECREASE

Effective for dates of service on or after July 1, 2010, the MO HealthNet fee-for-service maximum allowable rates for the services listed below will be decreased by two percent as a result of the Governor's Expenditure Restriction Plan for FY 2011. MO HealthNet will reimburse the lower of the provider's billed charge or the maximum allowable amount for the date of service billed. Providers may not bill MO HealthNet at a higher rate than they charge their private pay patients. Providers must bill MO HealthNet their usual and customary rate.
