#### HOSPICE RATE CHANGE

Attached is the MO HealthNet Hospice payment rates effective October 1, 2010 through September 30, 2011. The rates in Attachment A are listed by Core Based Statistical Area (CBSA).

The Balanced Budget Act of 1997 requires hospices submit claims for payment for hospice care furnished in an individual's home based on the geographic locations in which the services is furnished, as opposed to the location of the hospice. In order to comply with this requirement, use the attached rate schedule when billing for services provided in an individual's home when that residence is outside the CBSA in which your agency is located. If services are provided in a CBSA with a higher rate than the CBSA rate for the location of your agency, please e-mail the Provider Enrollment Unit at [providerenrollment@dss.mo.gov](mailto:providerenrollment@dss.mo.gov). Include your provider name, NPI number, residence service counties, and request the rate for the CBSA be placed on your file. This will allow you to be reimbursed at the appropriate CBSA rate.
