MAXIMUM ALLOWABLE RATE INCREASE

Effective July 1, 2014, the MO HealthNet fee-for-service maximum allowable rates for the Home and Community Based Services listed below are changing. The follow rates are being adjusted to reflect the rates that were appropriated for State Fiscal Year (SFY) 2014. The SFY 2015 rate reflects the rate for SFY 2014 being paid over a twelve (12) month period. For further explanation refer to provider bulletin Volume 36, Number 09, published October 1, 2013 at http://dss.mo.gov/mhd/providers/pdf/bulletin36-09_2013oct01.pdf.

MO HealthNet will reimburse the lower of the provider's billed charge or the maximum allowable amount for the date of service billed. Providers may not bill MO HealthNet at a higher rate than they charge their private pay patients. Providers must bill MO HealthNet their usual and customary rate.
