



## MO HealthNet HELP ON-LINE TRAINING CONFERENCES

THIRD QUARTER - 2008

### Description

The MO HealthNet Division (MHD) provider education staff can provide interactive training to providers at their office location using the Internet and telephone conference lines. The presentations are relatively short and are usually limited to 60 to 90 minutes in length.

**Providers should be certain the training session they are requesting matches their provider type. Previous MO HealthNet legacy numbers beginning with 50 are for clinics/groups using performing provider numbers.**

The help training conferences can be for an individual or for a group up to ten (10) connections. However, each registration is limited to one telephone dial-in and one (1) Internet connection. If more than one (1) person at a provider location is participating, the phone and Internet connection must be shared by all participants at the location. If you intend to use a speaker phone, you must ensure that there will be minimal background noise and conversation.

The provider must have access to the Internet and must be using a current browser program (Internet Explorer 5/6/7 or Netscape 5 or higher, that is Windows Vista compatible).
