Figure 1. Representative Missouri Temporary Assistance Caretaker Characteristics June 2002

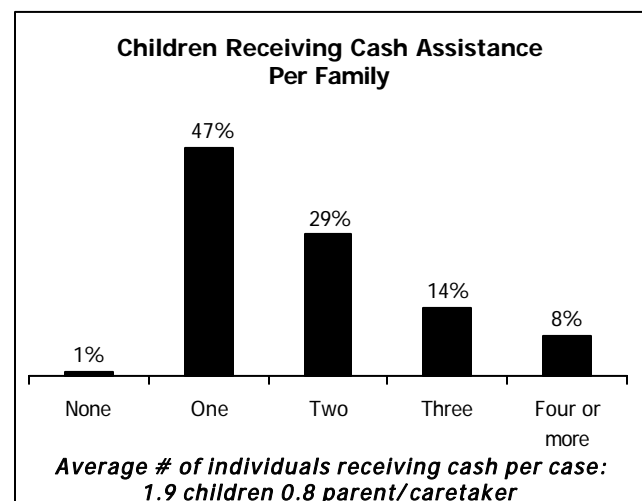
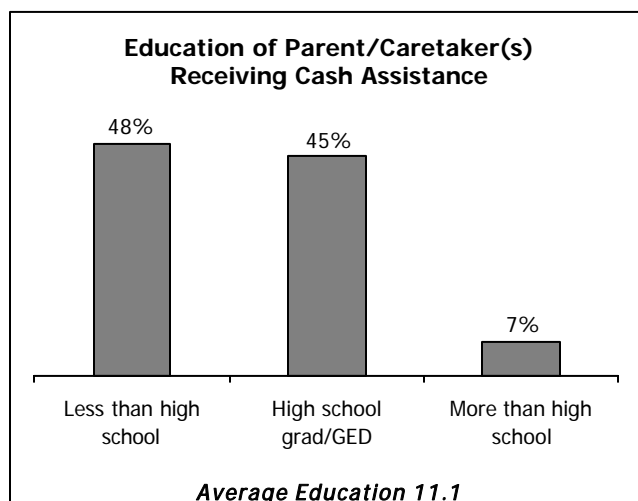
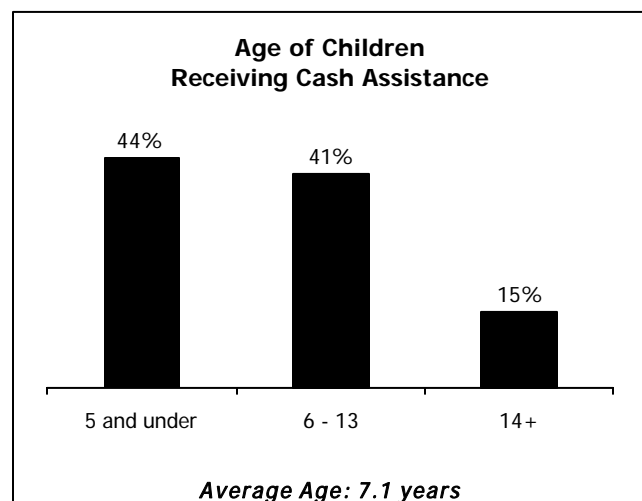
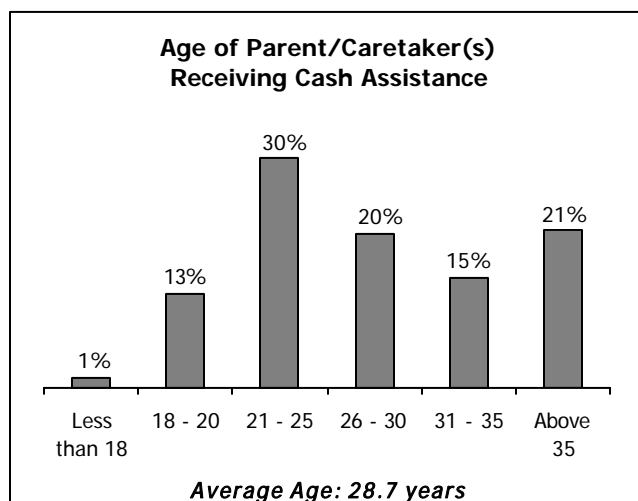
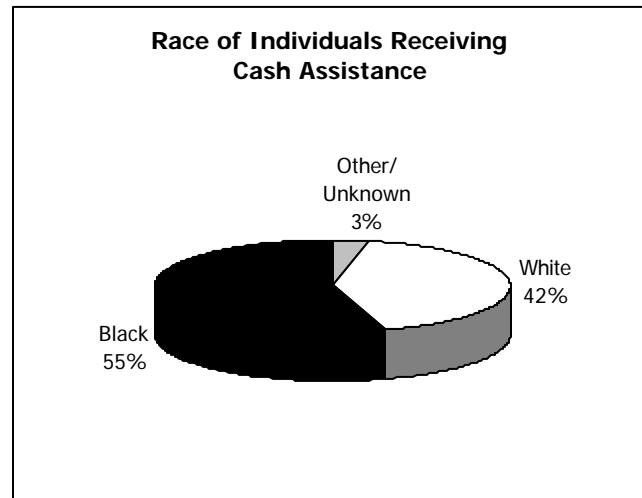
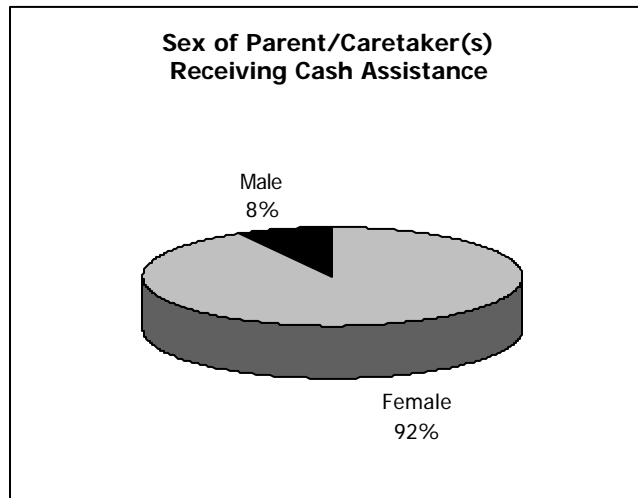
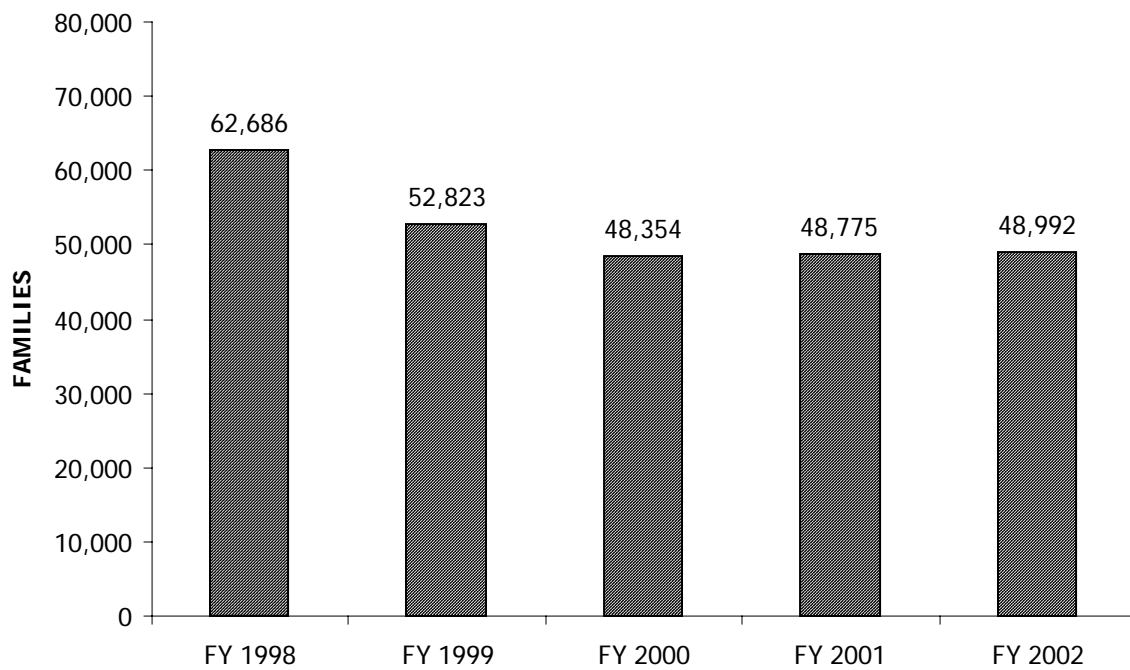


Figure 2. Temporary Assistance

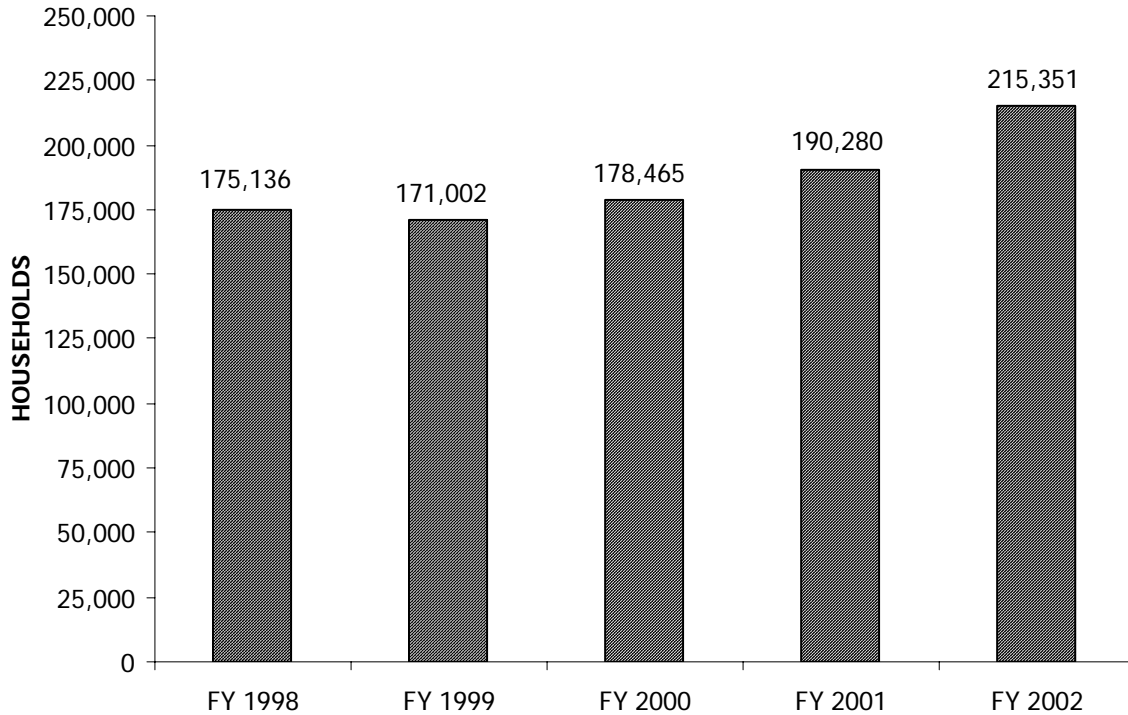
