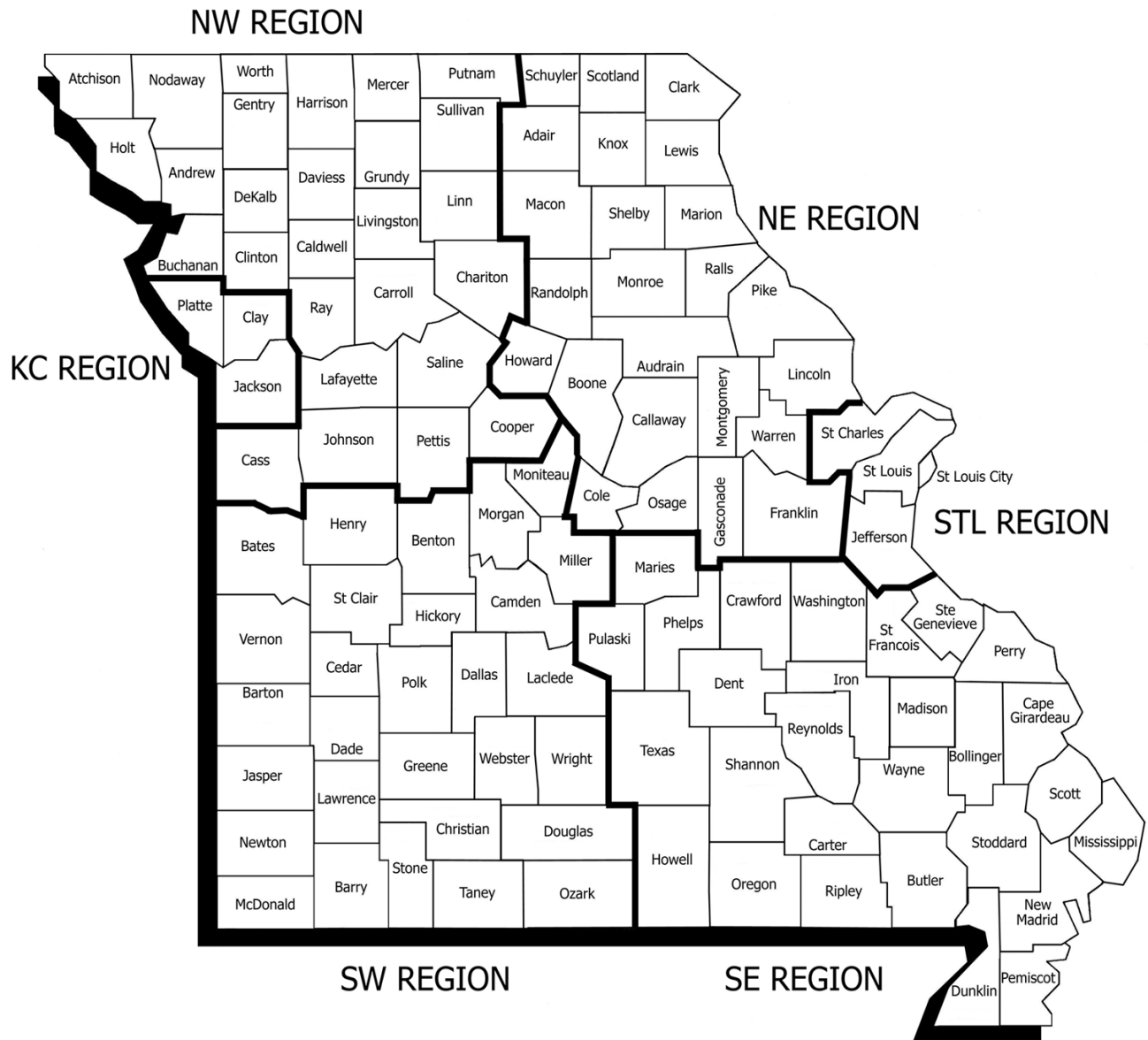

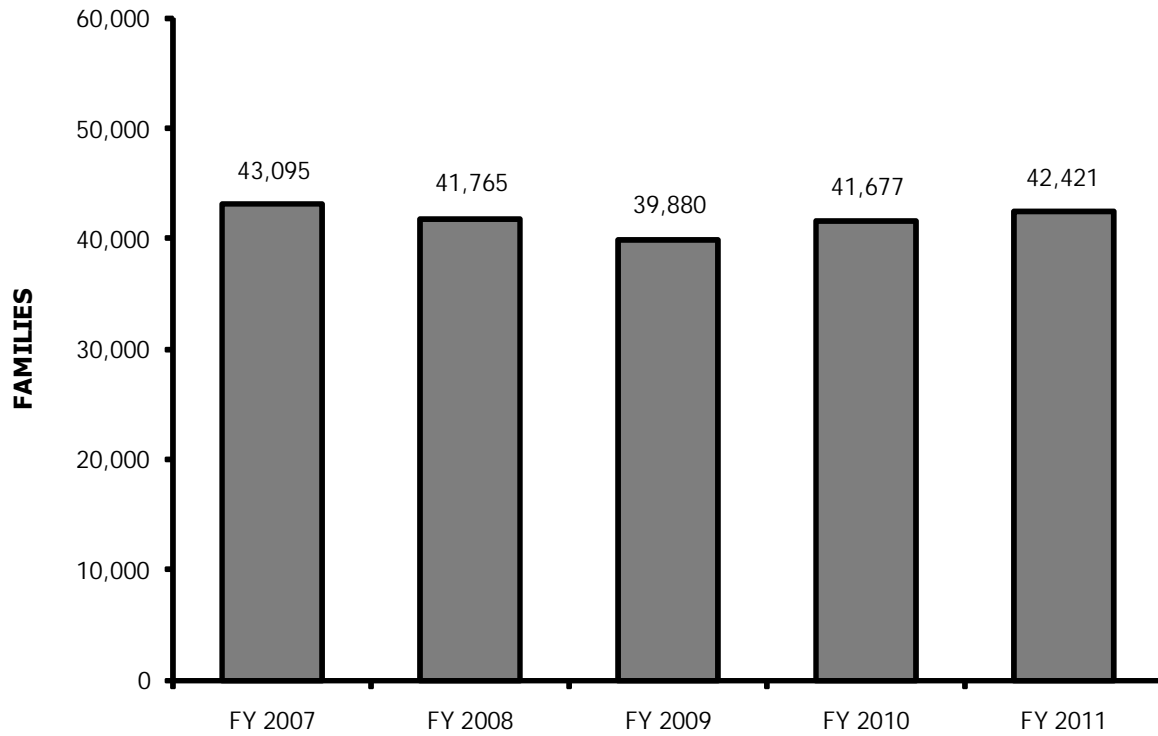

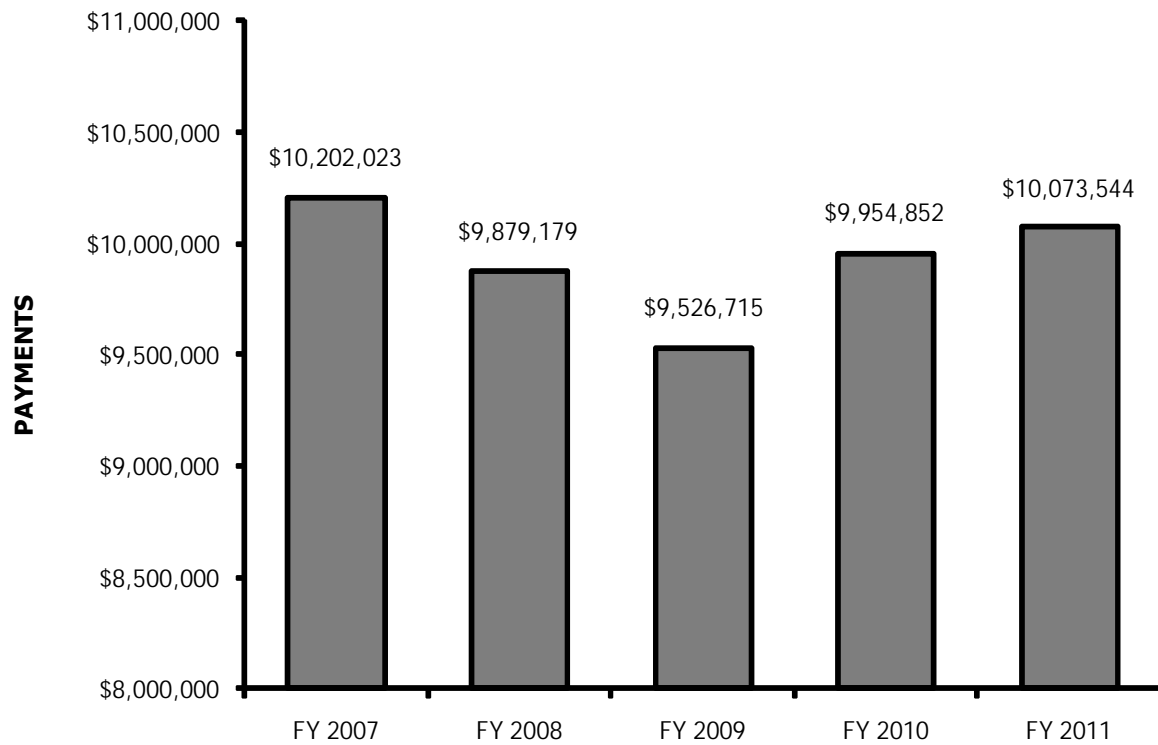

Average Monthly Caseload Fiscal Years 2007 - 2011

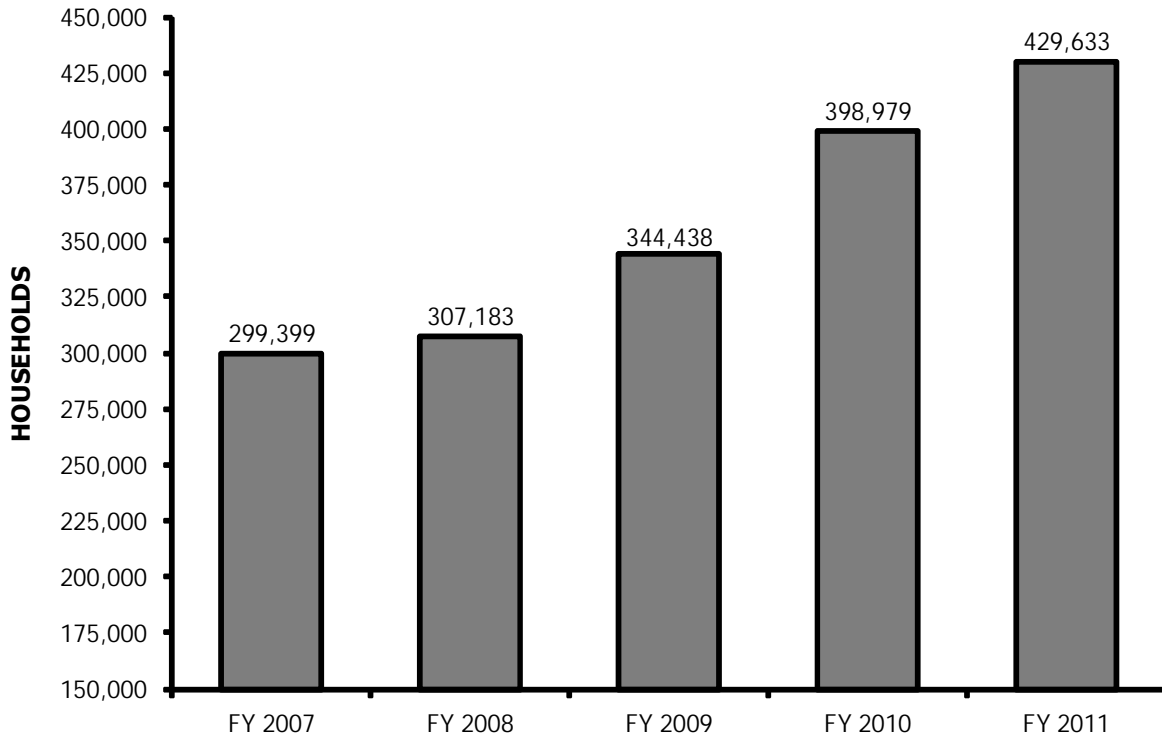
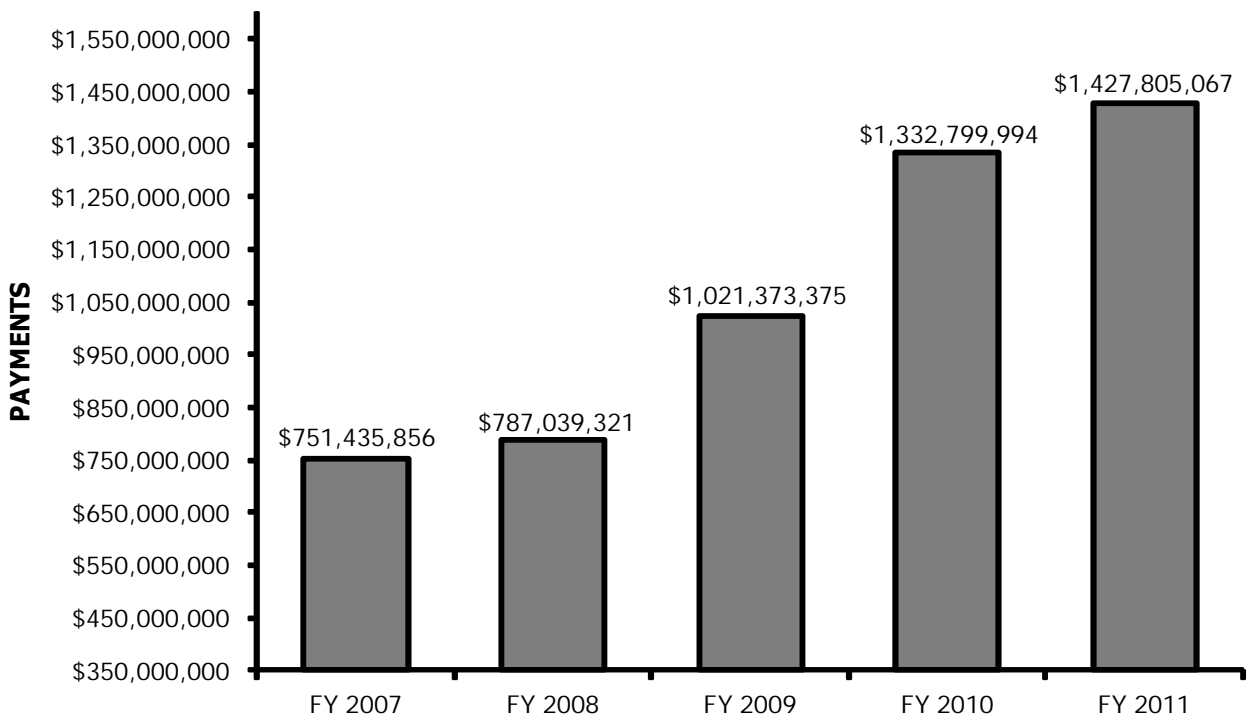


Figure 6. Food Stamps
