## ***Introduction***

### **The IIS Program**

Missouri families in crisis can receive help from Intensive In-home Services (IIS) when faced with the removal of a child or children from their home. Removal of children is sometimes necessary due to problems such as child abuse and neglect, family violence, drug dependency, delinquency, or other crisis circumstances. IIS offers intensive, short-term, home-based, crisis intervention services with the goal of keeping families safely together whenever possible. IIS services are flexible and can be provided any time based on the family's needs. Trained primary specialists from either the Children's Division or contracted vendors help families with skill-based interventions such as individual and family counseling, parenting education, child development training, household maintenance education, nutritional training, job readiness training, as well as other community resources.

### ***Families and Children Accepted***

Each family accepted into IIS is represented by a *head of household*. The children identified as at-risk for out-of-home placement are referred to as *at-risk children*.

During state fiscal year 2008 (July 1, 2007-June 30, 2008), the number of at-risk children accepted into IIS was 3,356. The total number of families accepted into IIS was 1,655 and the total number of children, including at-risk children, was 4,072. On average, families accepted into IIS were comprised of 2.5 total children and 2 at-risk children (Appendix A).

## *Families and Children Not Accepted*

The 1,289 families not accepted for IIS during FY 2008 included 2,236 at-risk children (Appendices A and B). The most common reason (37%) that at-risk children were not accepted into IIS was due to lack of openings into the program with the children remaining at home.

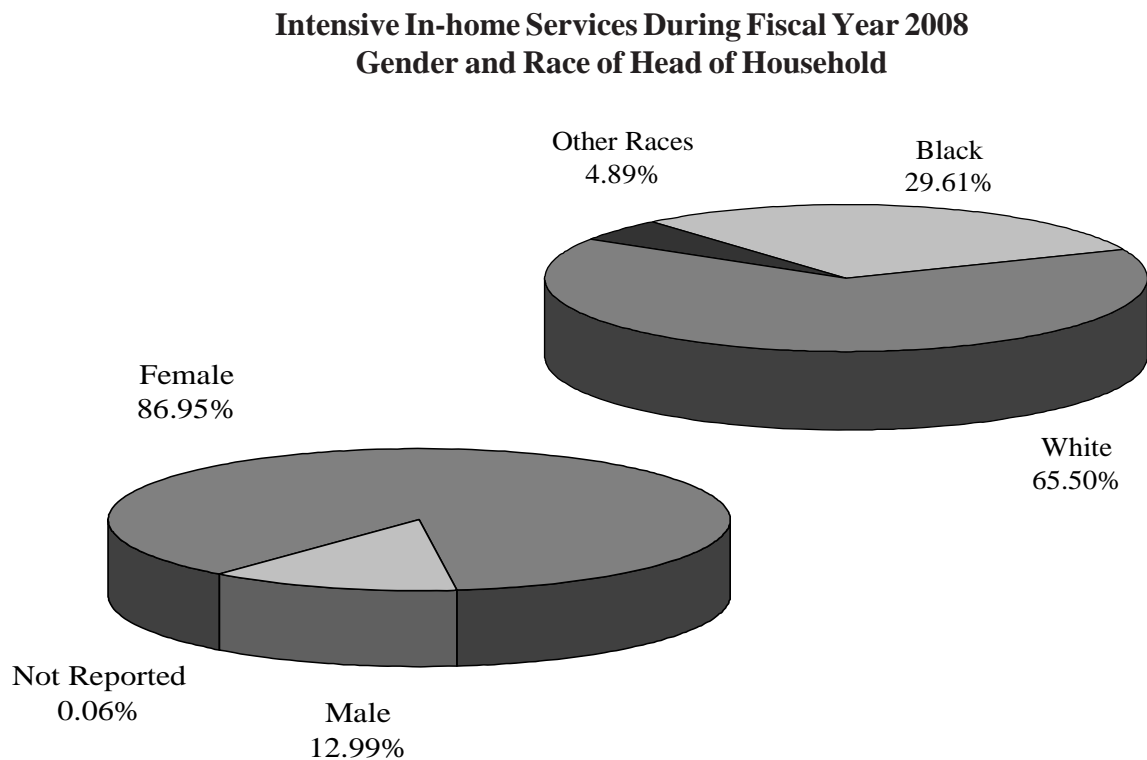
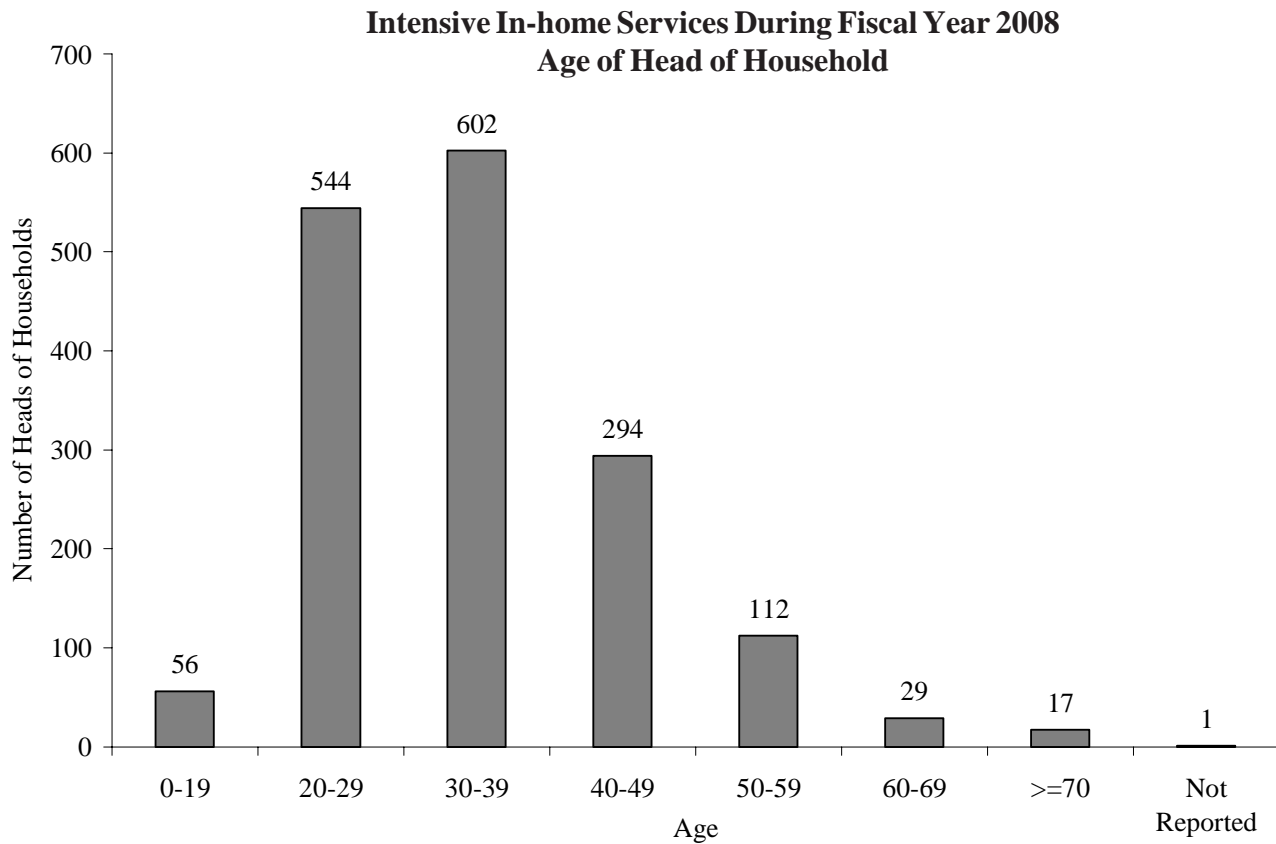
Referrals for accepted families are more likely to come from the Children's Division (81%) than any other referral source (Appendix C).

## Head of Household Characteristics of Families Accepted

During FY 2008, the head of household was most likely to be in the age range of 30-39, female and white (Appendix D, Appendix E, and Appendix F).



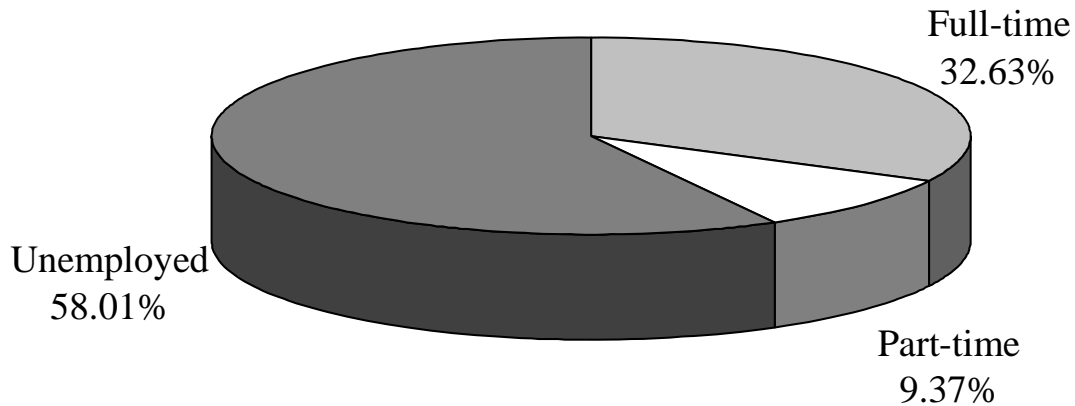

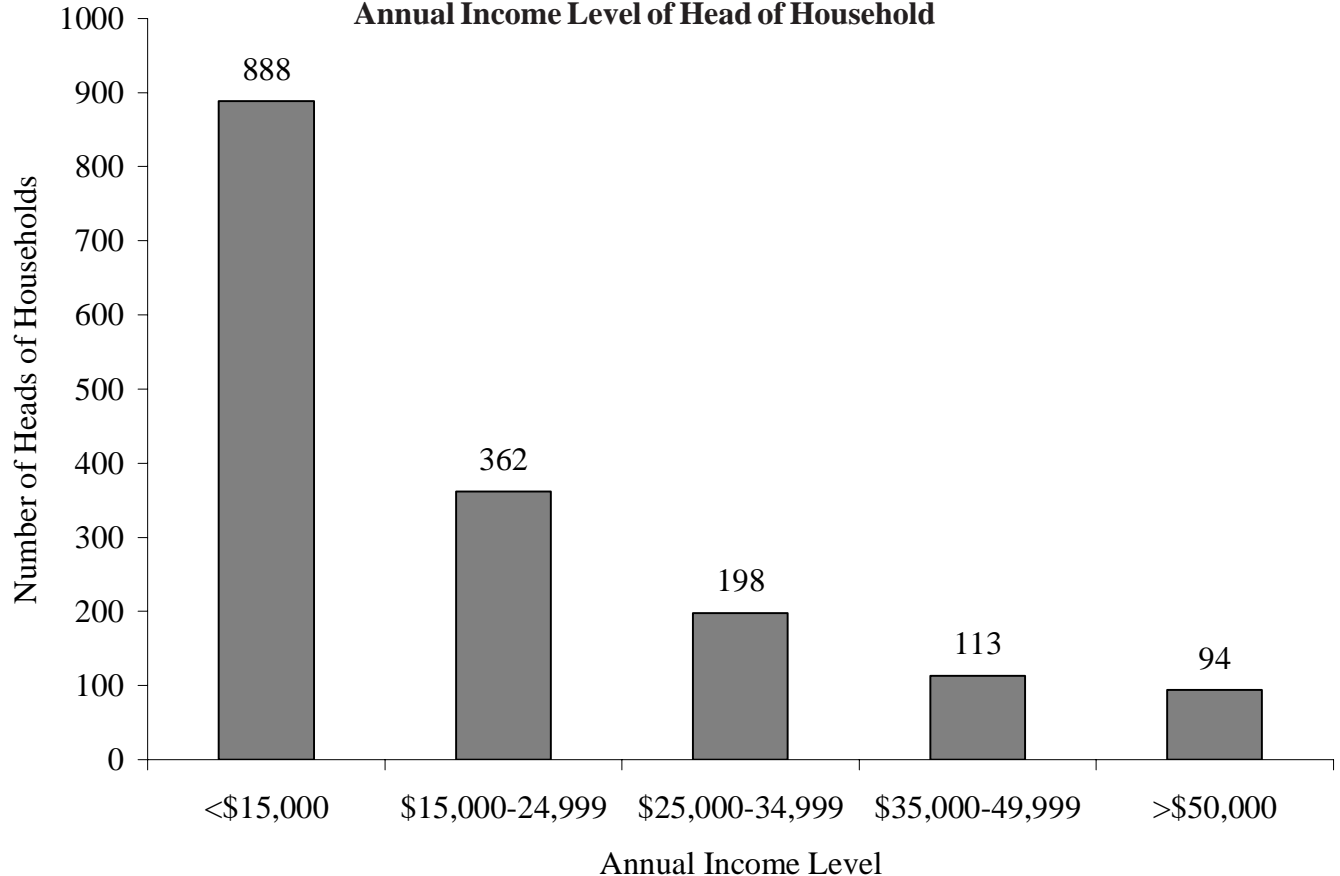

## *Head of Household Characteristics of Families Accepted (continued)*

Sixty-five percent of the 1,655 heads of households required help with parenting skills problems during FY 2008. The next most frequently addressed head of household problem was parent/child conflict at 38 % (623) followed by communication at 35% (578), mental health problems at 26% (432), and child neglect at 25% (413).

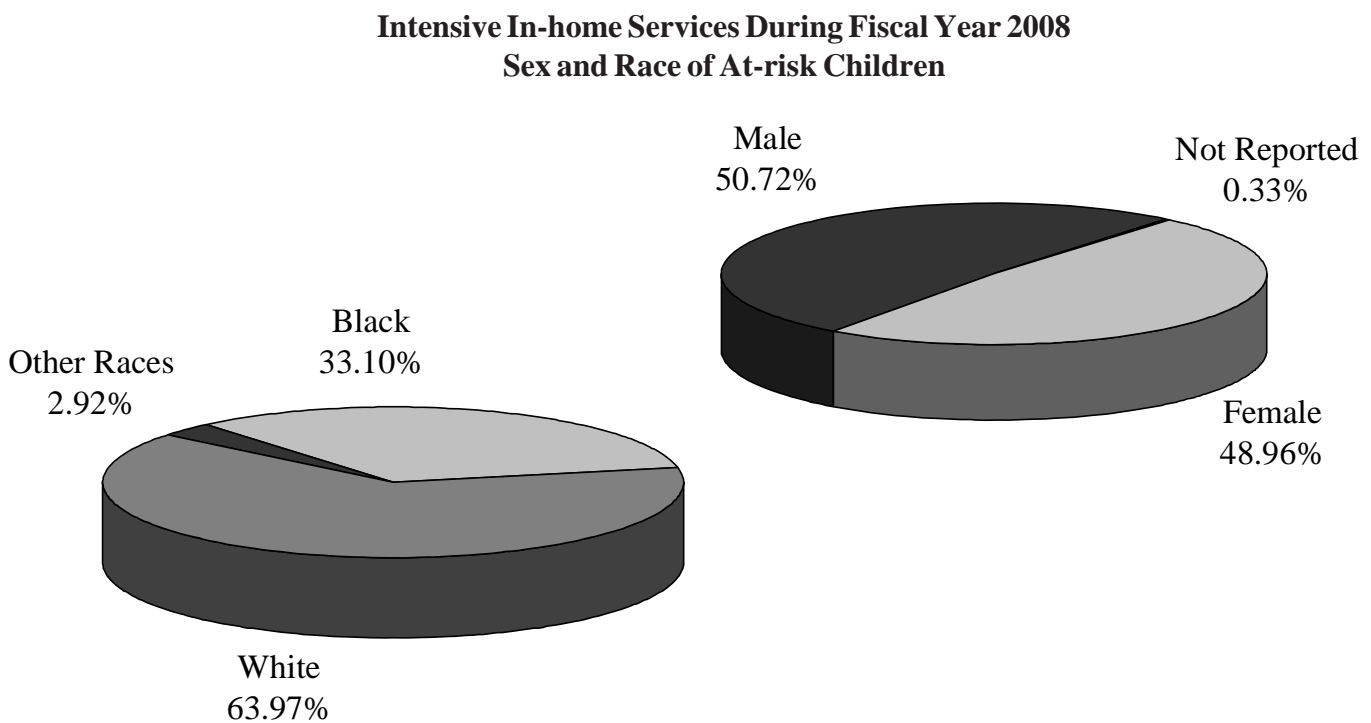
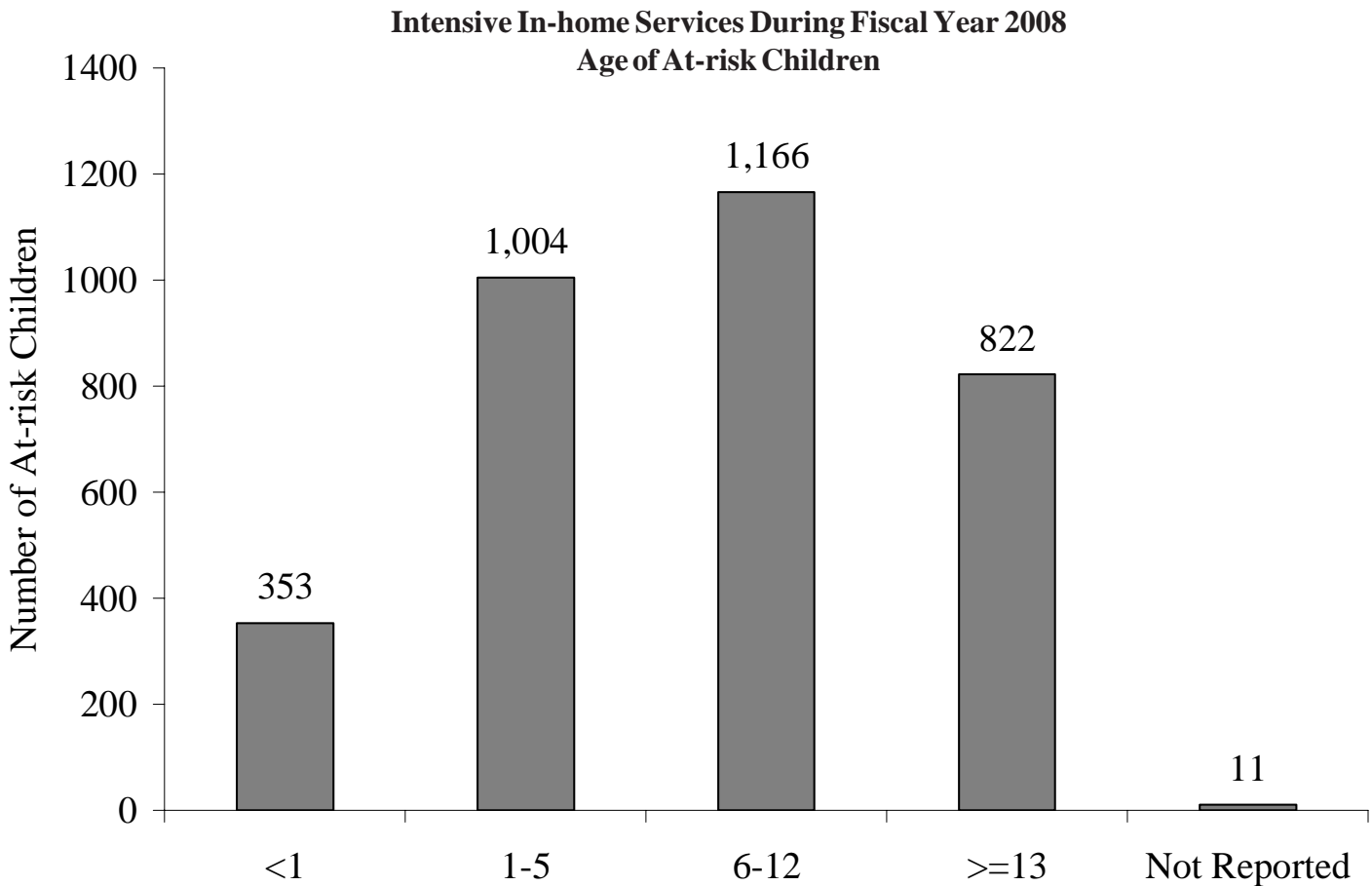

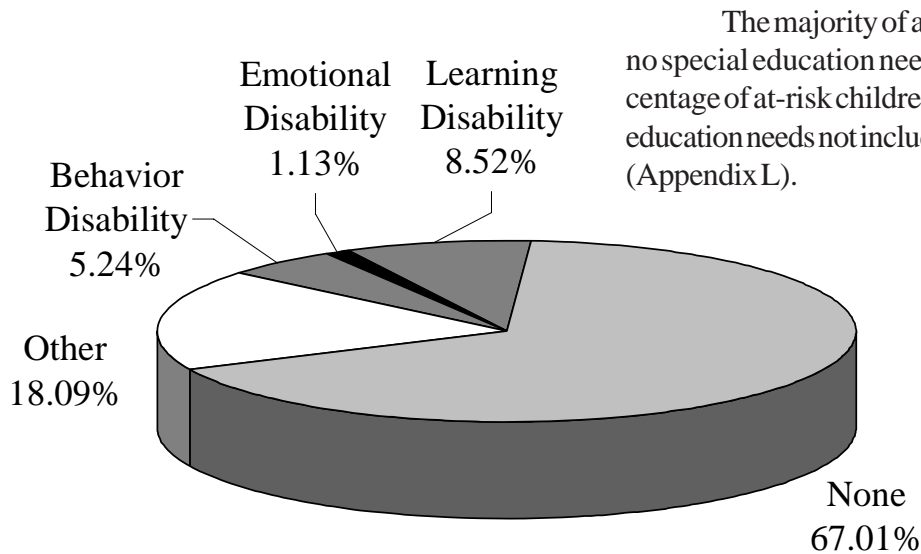
## At-risk Children Characteristics of Families Accepted

During FY 2008, most at-risk children (35%) were six to twelve years old (Appendix I). A slight majority of at-risk children were male, at 51%, versus female at 49%. Sixty-four percent of at-risk children were white, 33% were black and the remaining 3% were other races or not reported (Appendix J and Appendix K).

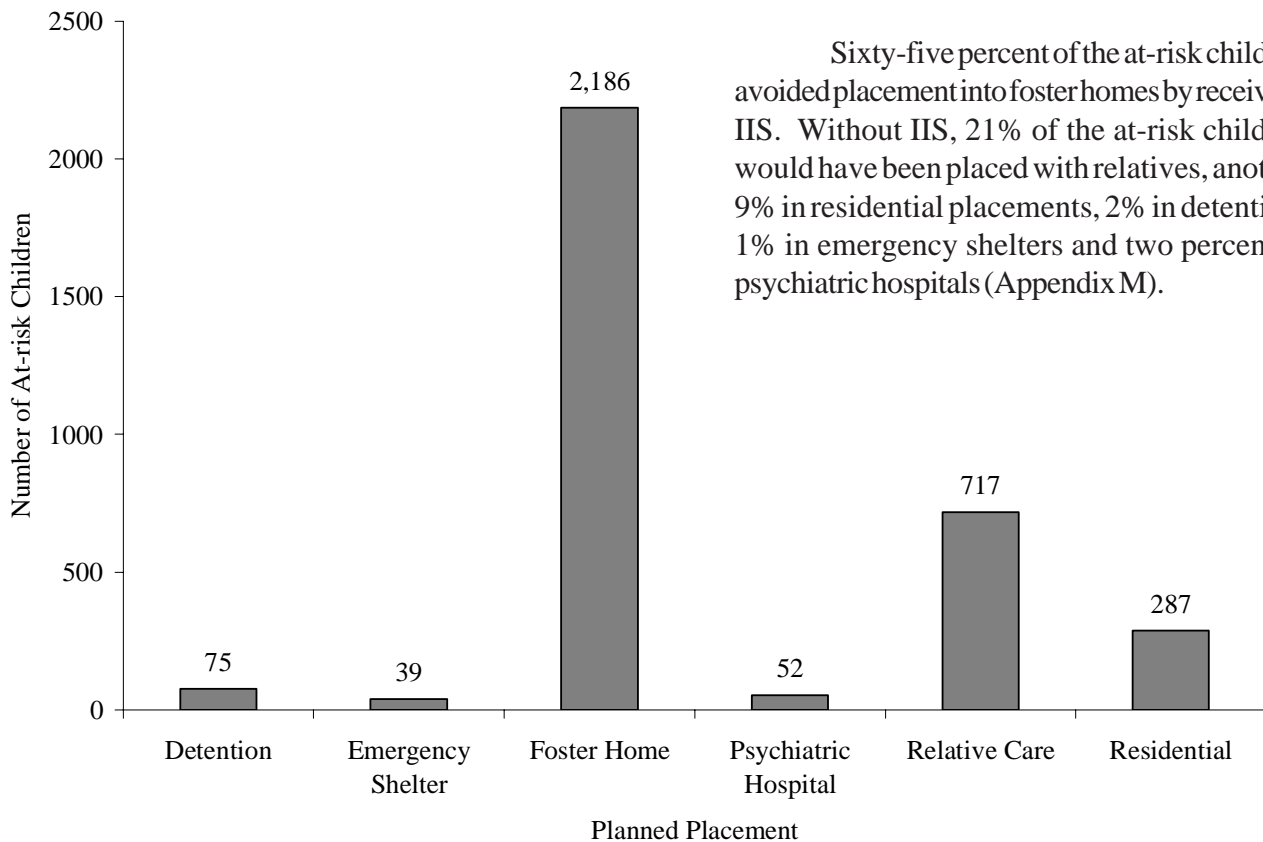


## At-risk Children Characteristics of Families Accepted (continued)

Thirty-three percent (1,105) of at-risk children had Parent/Child Conflict as the most common problem addressed in IIS during FY 2008. The next most common problems addressed were Parenting Skills Problems issues at 31% (1,029) and Communication at 29% (982).

## Prior Contacts

Of the 1,655 families accepted into IIS, 765 families had at least one contact with another agency prior to the IIS intervention. Those 765 families had a total of 1,160 prior contacts. Each family can have up to six prior contacts listed. Fifty-one percent of the prior contacts were with the Children's Division, followed by 21% with Adult Law Enforcement.

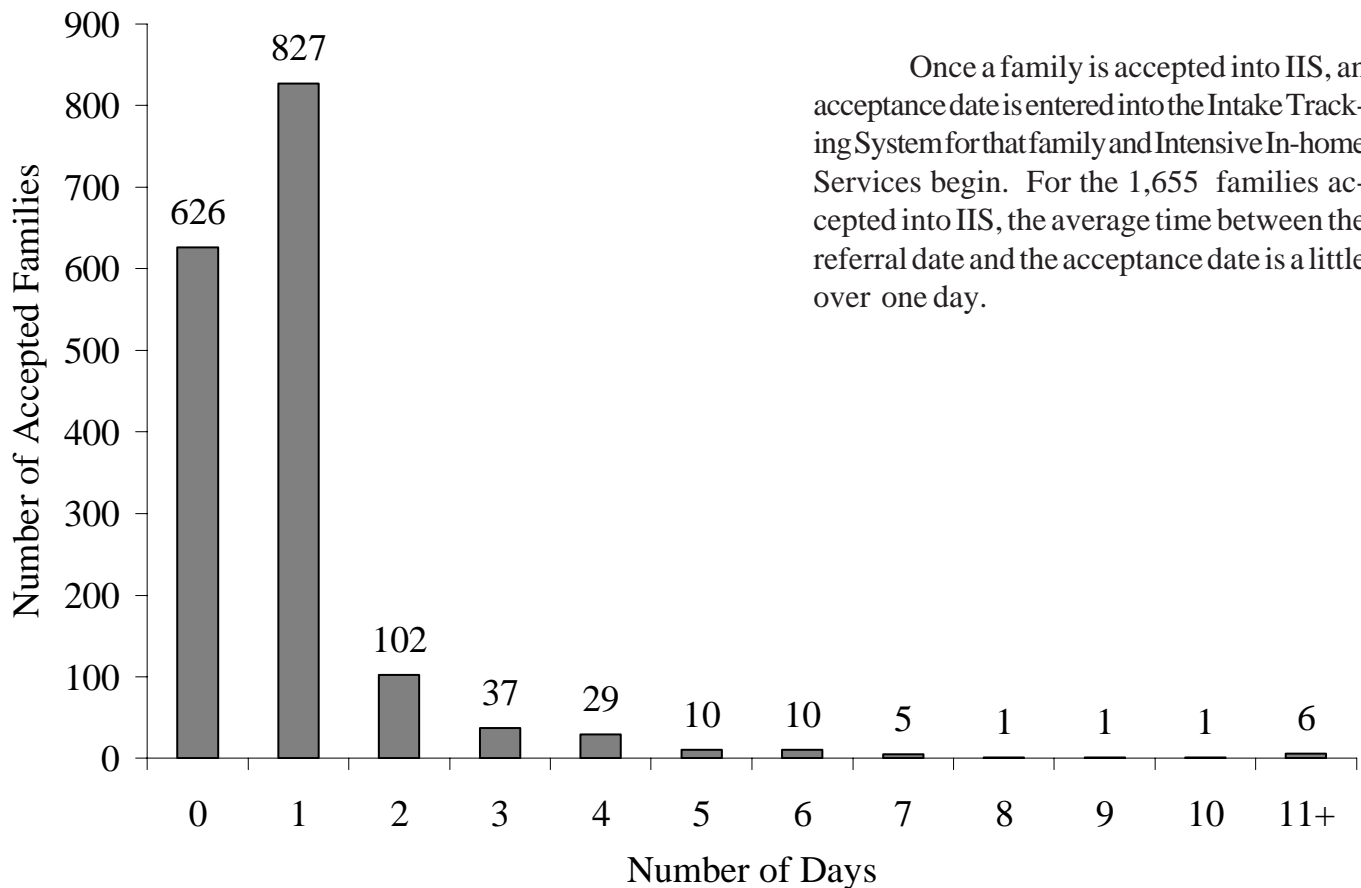

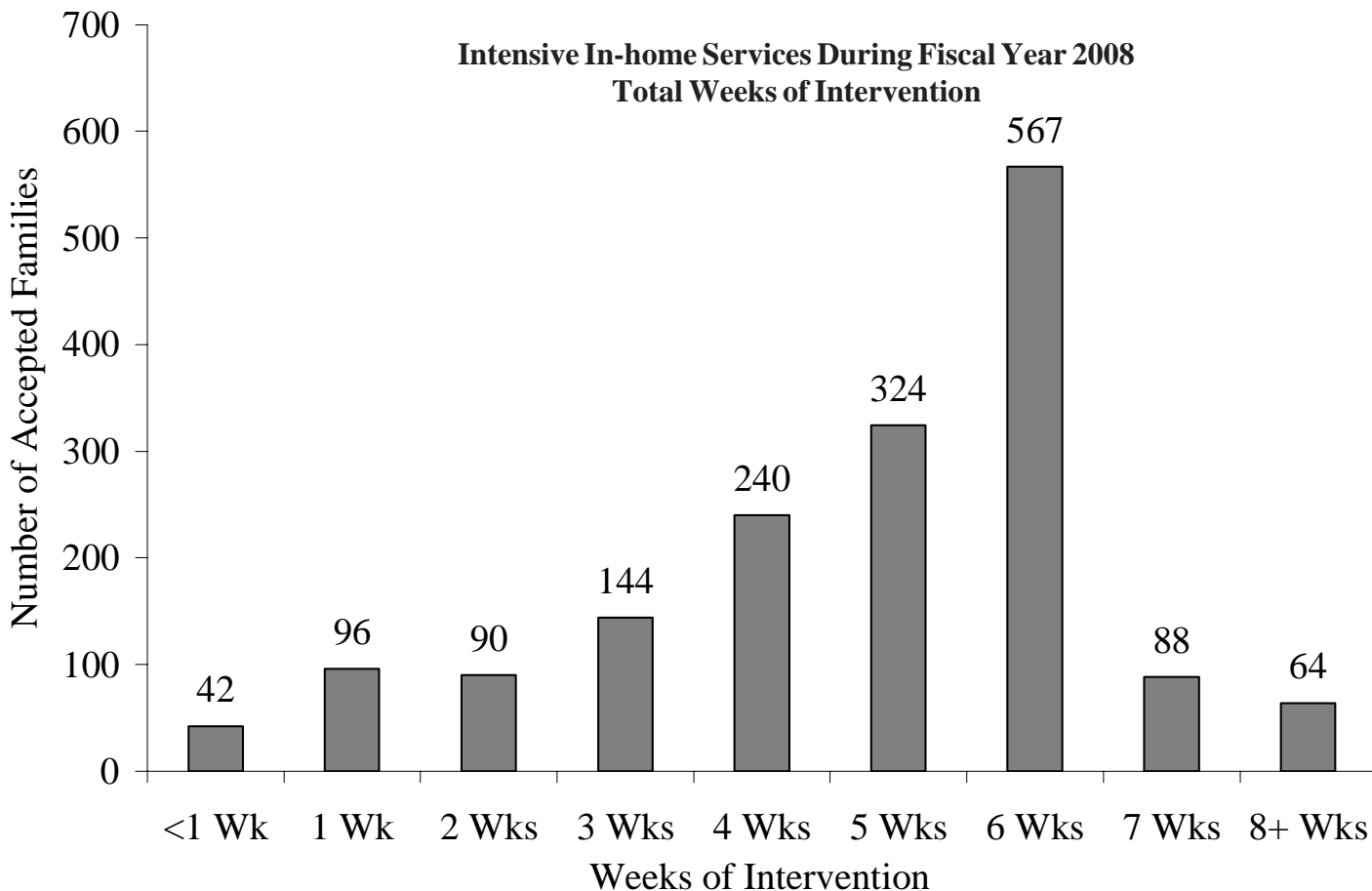
## Response Time

## Total Weeks of Intervention

During FY 2008, 91 percent of families exited IIS within 6 weeks of acceptance into the program. The average length of intervention was 5 weeks.



## Families and At-risk Children Exiting

Families and children who leave IIS during the fiscal year are considered to exit in one of the following categories: family intact, family not intact and other. Families are not intact if one of the following occurs: Child Ran Away, Child Moved Out of Home (not placed), Child Living with Relative or Guardian (not Court Ordered), Child Living with Relative or Guardian (Court Ordered), In Foster Home or Group Home, In Residential Treatment, With Division of Youth Services (DYS), In Juvenile Justice and In In-Patient Psychiatric Diversion. Other includes the following: Can't Locate Family, Information Not Available and Other. During FY 2008, 85% (1,382) of 1,623 families and 89% (2,937) of 3,299 at-risk children exiting IIS were reported to be in intact families (Appendix N).

## ***Outcomes***

### **Introduction**

The goal of Intensive In-home Services (IIS) is to allow families in crisis to remain safely together. Outcomes can measure how well this goal is met for families after their exit from IIS intervention. Whether or not an at-risk child (ARC) enters Children's Division (CD) alternative care or is listed as a victim of a substantiated child abuse/neglect (CA/N) hotlines are two outcomes.

Children who exited IIS during fiscal years 2004, 2005, 2006 and 2007 were checked to see if they had entered CD custody or if they were listed as a victim of a substantiated CA/N report during IIS intervention up to 48 months of exiting IIS. These past fiscal years were used to give children exiting enough time to see if the events had occurred. FY 2004 is the only fiscal year, at the time of this report, to allow a 48 month follow-up. FY 2005, FY 2006 and FY 2007 have follow-ups of 36, 24 and 12 months, respectively.

The following table gives the number of families and at-risk children who exited IIS during four fiscal years. Each family and child are counted only once. If a family or child were involved in multiple IIS interventions, the exit associated with the lowest intervention number was used.

### **ARC Cases by Provider**

Intensive In-home Services are handled either by in-house Children's Division staff or by contracted providers. Contracted providers managed most of the cases for at-risk children exiting during FY 2004, FY 2005, FY 2006 and FY 2007. For example, 78% of the cases of at-risk children exiting during FY 2004 were in contracted caseloads versus 22% in in-house. The number and percentages of cases by provider for each of the four fiscal years are shown in the table below.

### ARC and Children's Division Alternative Care

ARC exiting IIS during each of the four fiscal years were checked to see if they entered alternative care in the months following their exits. If there were multiple entries into Legal Status 1 (LS1) for the ARC, the first entry was used. The following table shows the number of statewide ARC who entered alternative care from during the IIS intervention to 48 months of their exit from IIS. Most of the ARC did not enter LS1 alternative care during or after their IIS intervention as shown in the following chart.

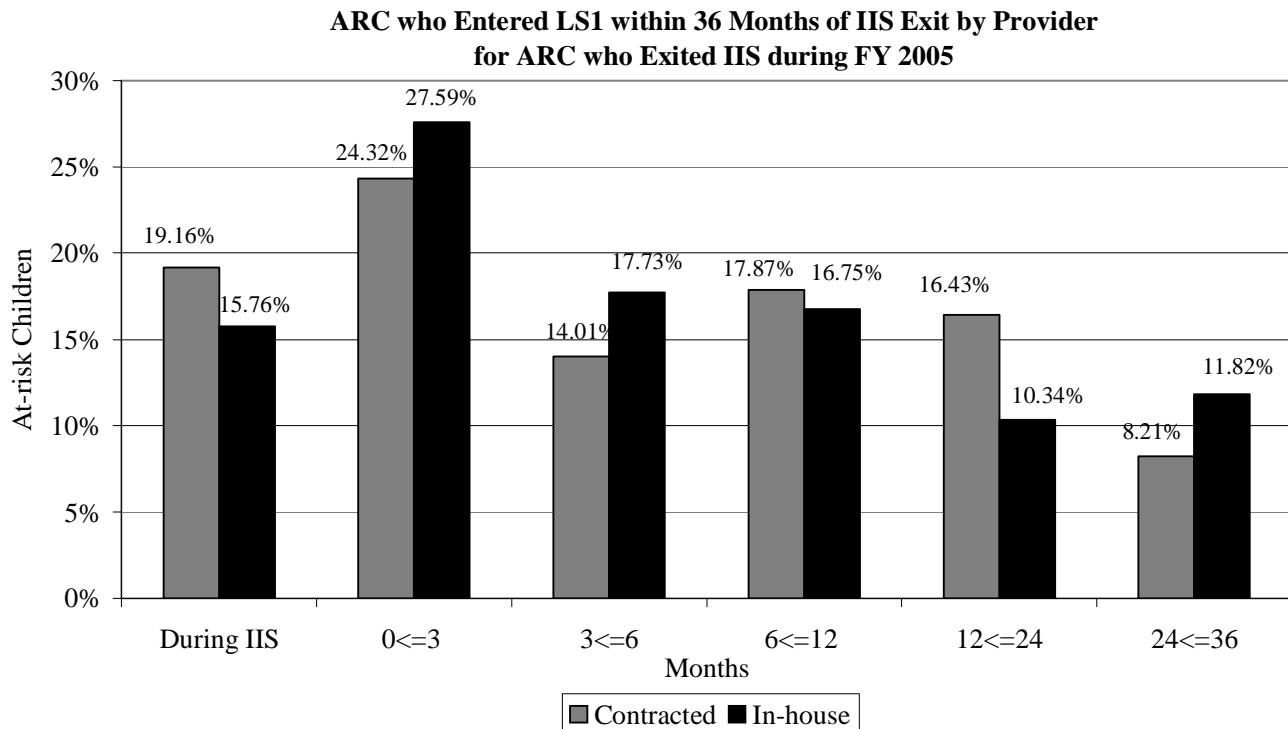
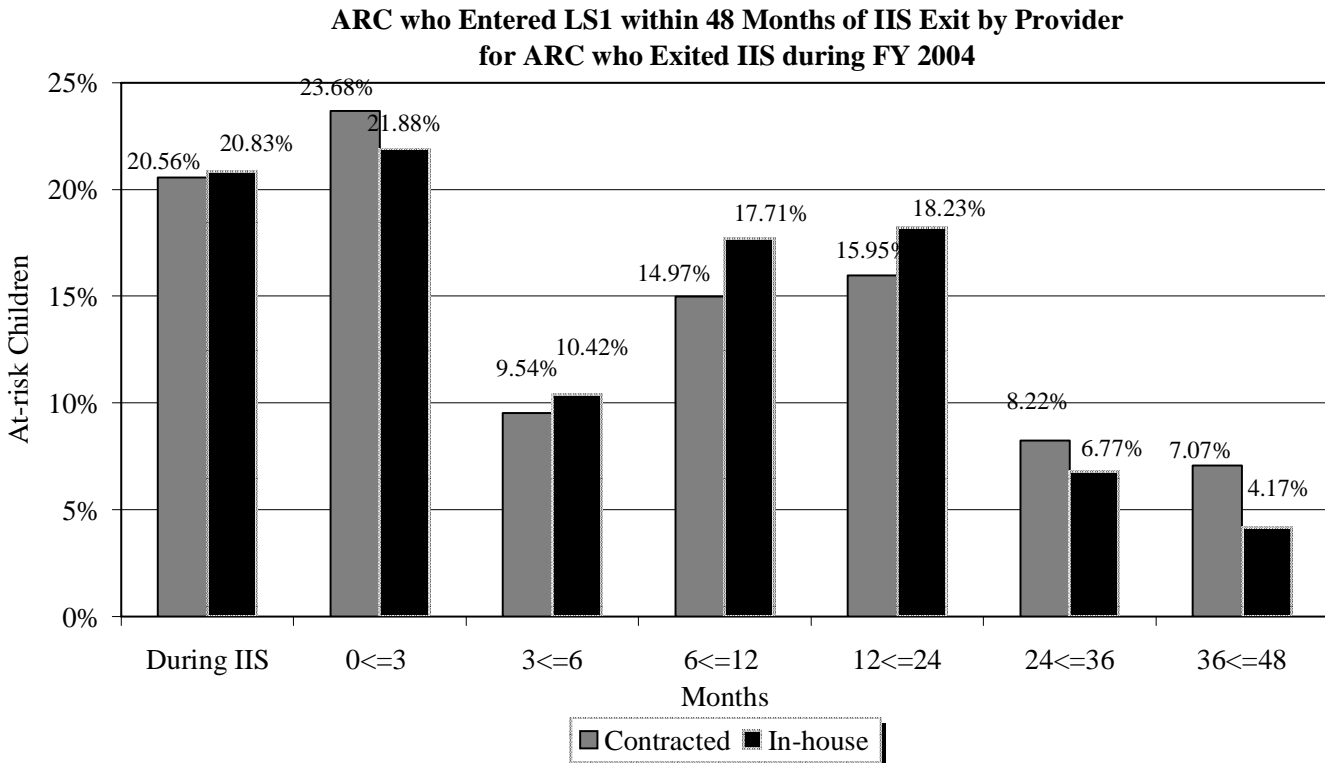

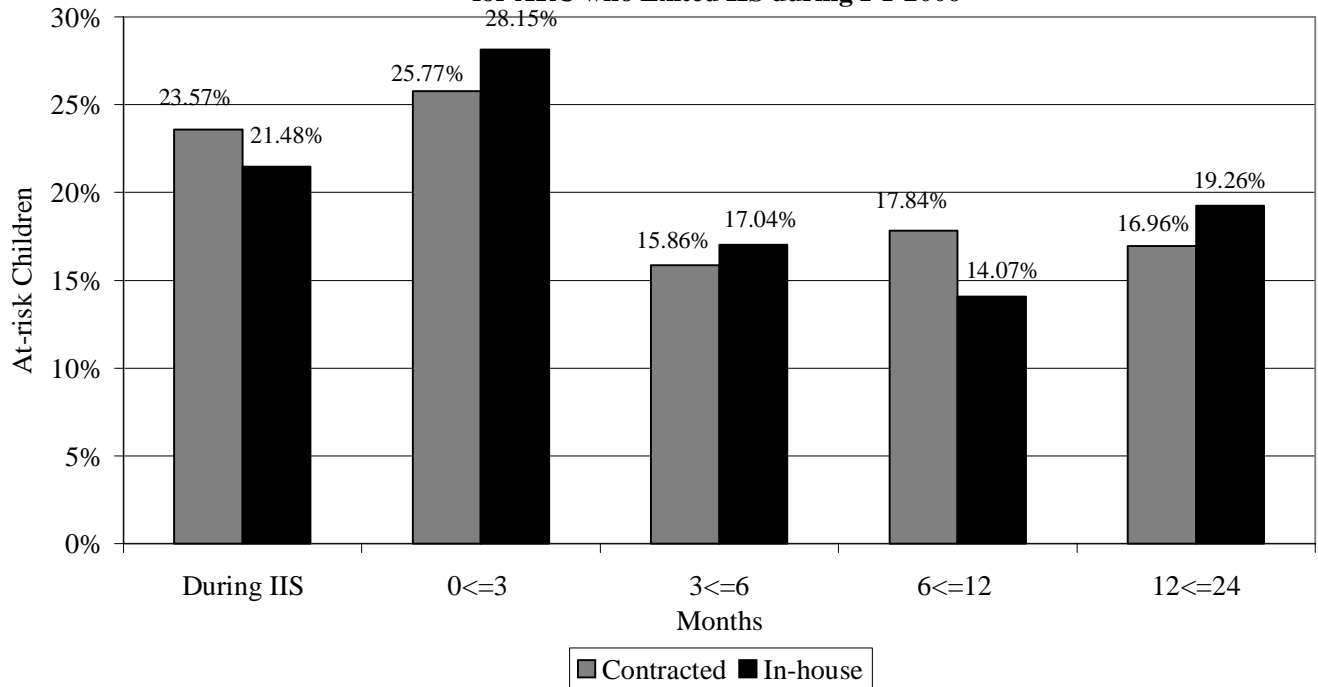
### ARC who Entered LS1 within 48 Months of Exit by Provider

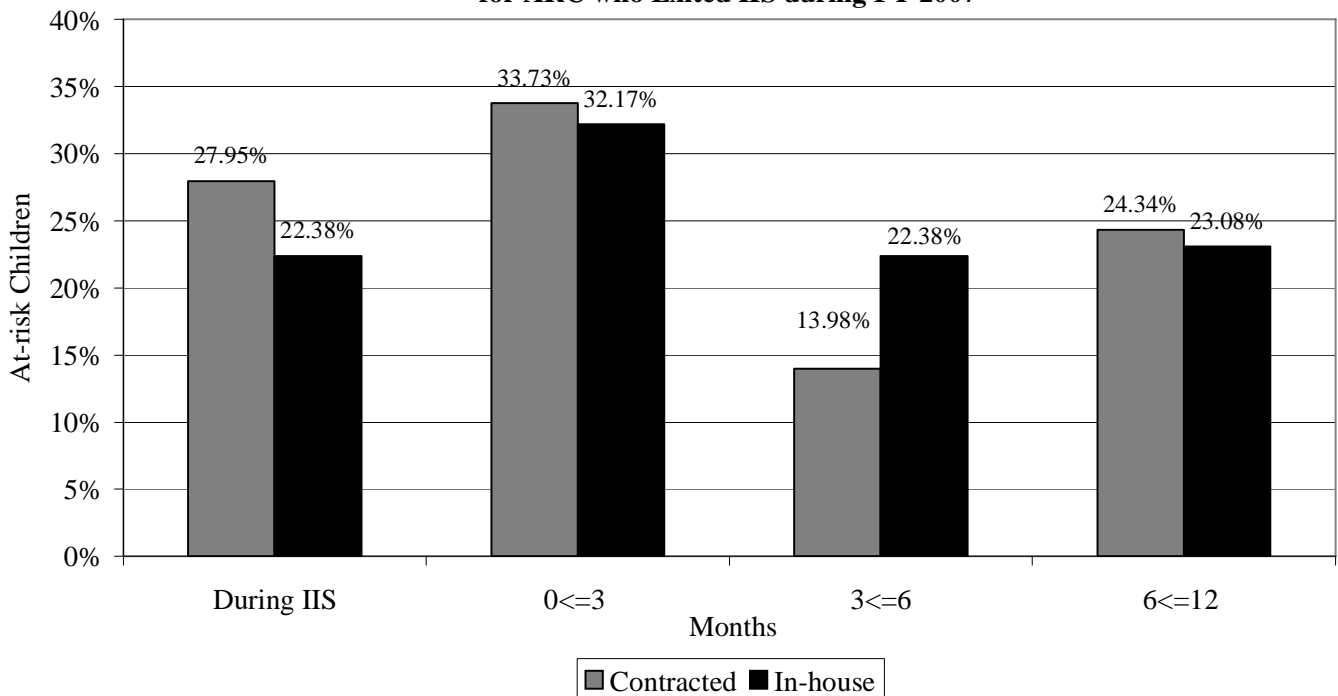

### ARC and Child Abuse/Neglect (CA/N) Reports

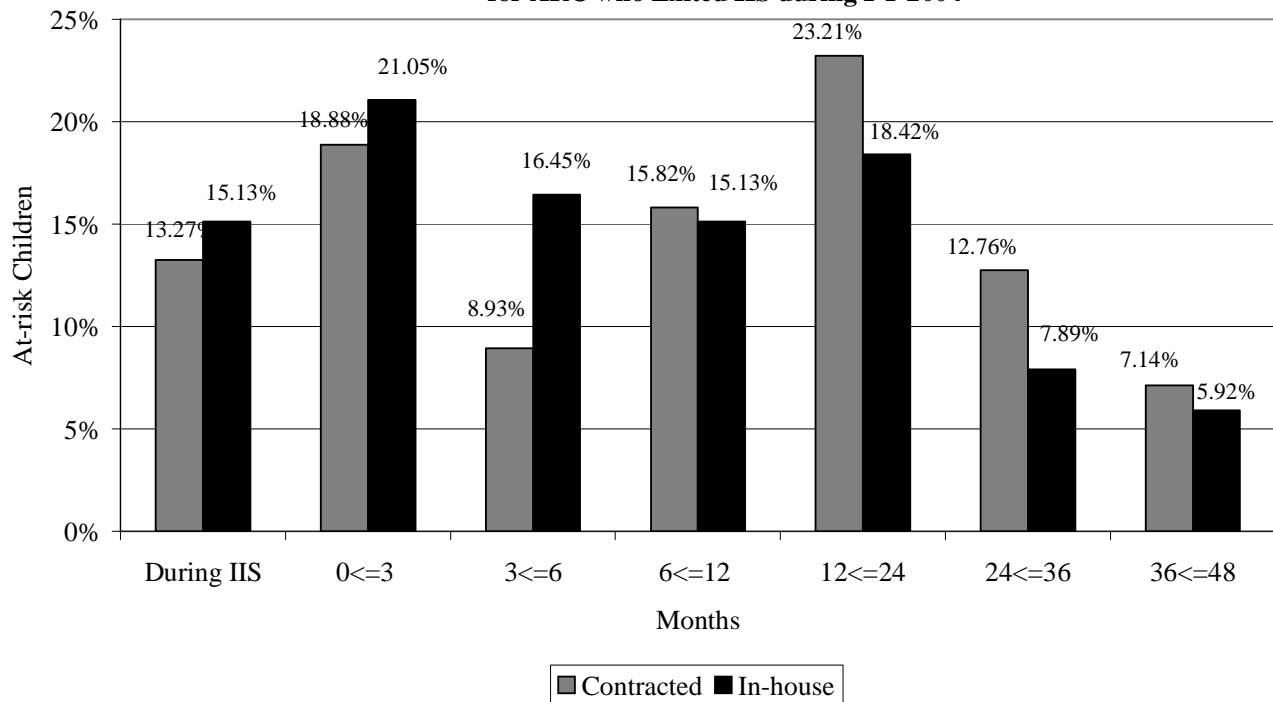

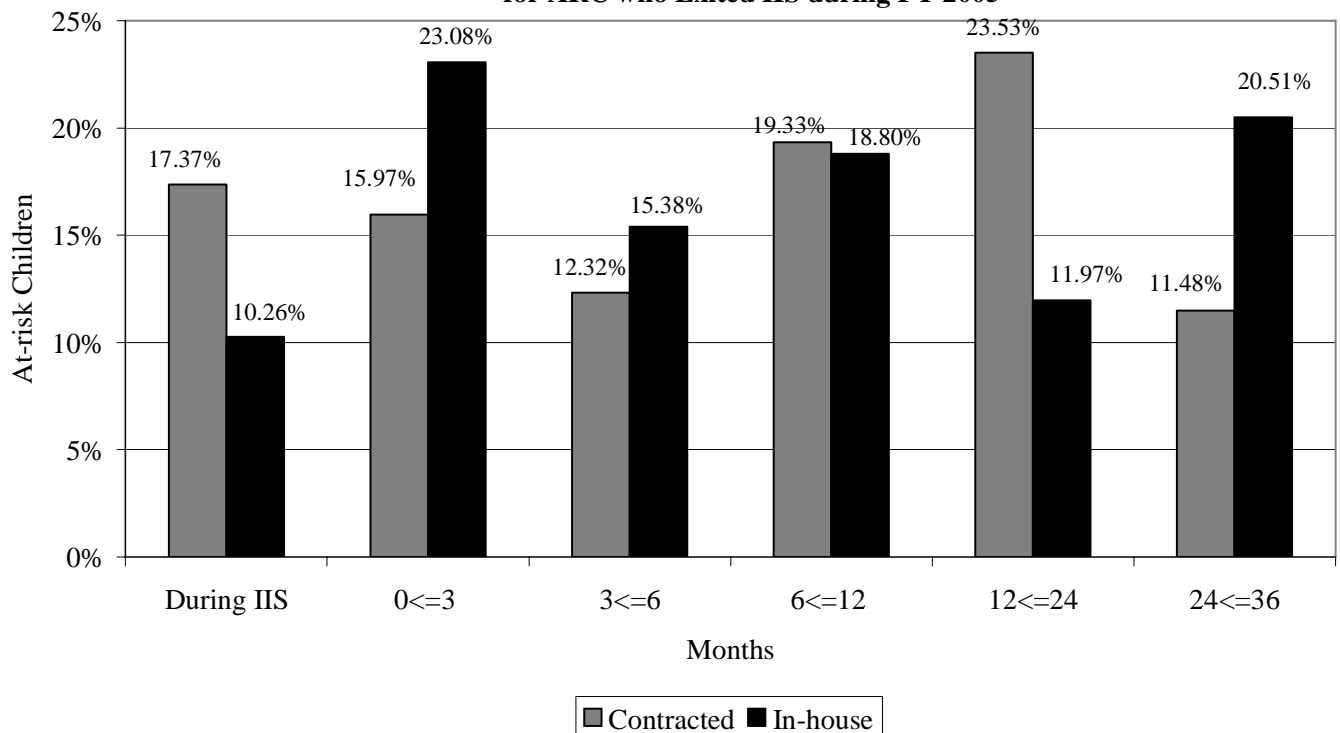

for ARC who Exited IIS during FY 2004**

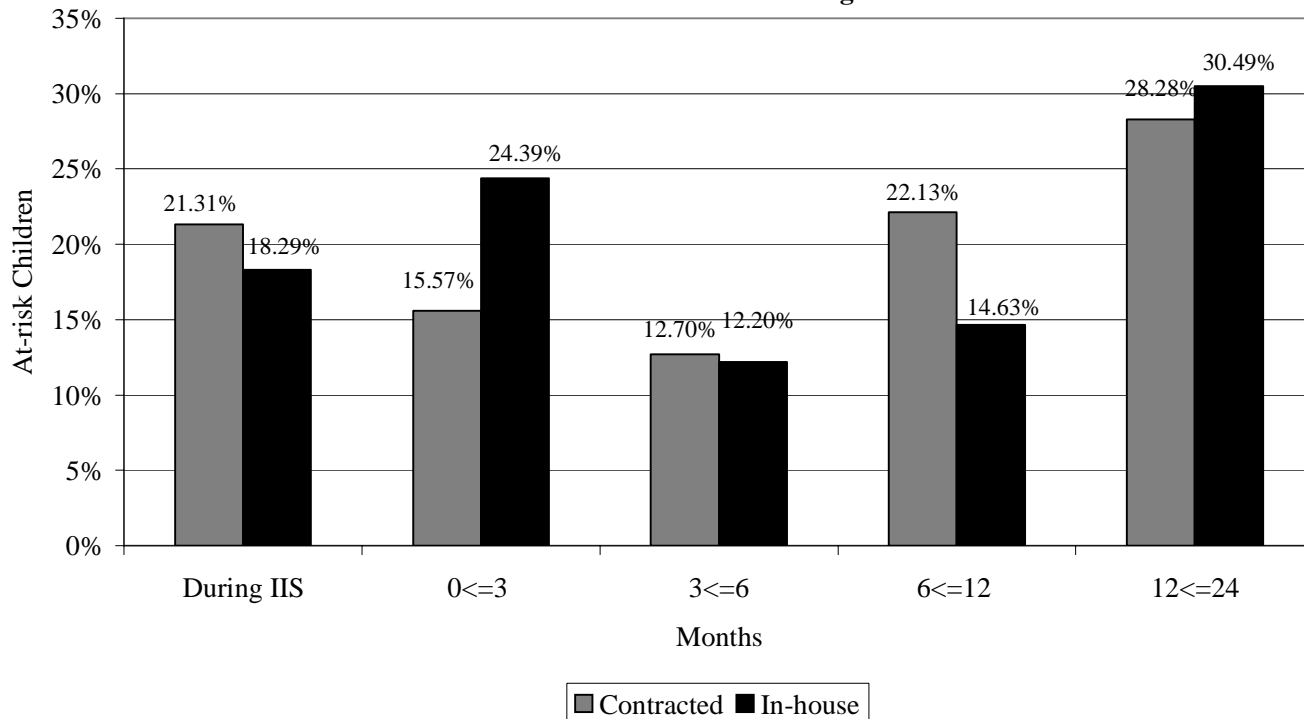


**ARC in Substantiated CA/N within 36 Months of IIS Exit by Provider  
for ARC who Exited IIS during FY 2005**

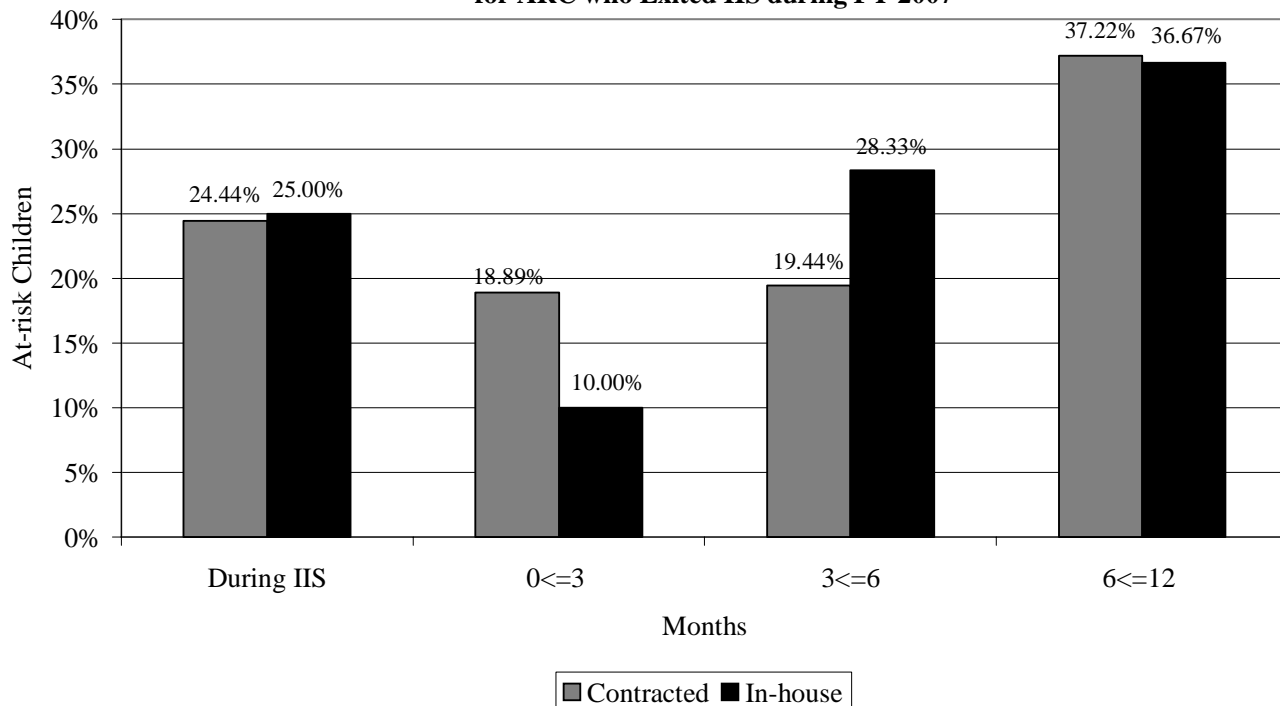
