



Managed Care Performance Withhold Program Payout Model

This is based on a 3% withhold and 14 total HEDIS measures (see page 2).

Standard Payout Based on Each HEDIS Measure Will Be Made if One of the Following Conditions are Met, Whichever is Most Beneficial to the Health Plan

Definitions

*Percentile requirements refer to the National Committee for Quality Assurance (NCQA) Quality Compass percentile rankings for Managed Care Organizations for the measurement (performance) year being evaluated.

After the Standard Payout percentage is determined based on the above criteria, each health plan can earn an additional Supplemental Payout based on the above criteria. The combined, total payout for the Standard Payout and Supplemental Payout shall not exceed the 3.00% total withhold percentage set aside for each health plan.

Only one Supplemental Payout will be paid in the event both 25% aggregate and 50% aggregate are achieved. The health plan will receive the most beneficial of the two. These amounts will not be combined to equal a payout of 75% aggregate.

Use standard rounding (1.487 = 1.49) to arrive at a final value out two decimal places for both baseline and performance year as well as comparisons to benchmarks.

Percentage points are different from a percent increase; a two-percentage point increase over 10% is 12%.

For the State Fiscal Year 2020 contract, the baseline is based on health plan specific Calendar Year 2018 rates and the measurement (performance) year is based on health plan specific Calendar Year 2019 rates. In future contract periods, the baseline year will be reset reflect the year prior to the measurement year.
