# **History Review**

- Carol discussed the last several meetings
  - o Goals
  - o Items of discussion
  - o Recommendations put forth to the board

### Discussion on Reframing our work in the current landscape

- Christy, Cindy Reese and Lisa are working with a group in developing a kindergarten readiness recommendation plan
  - The purpose is to get children ready for kindergarten through self-regulations and social/emotional curriculum.
  - The group is in the Columbia area.
- MARC/MCEL has a strong interest and is convening stakeholders early in summer
- We need to support the growth that is happening with other groups.
- Educare is providing trainings to registered child care providers
  - The training is preservice and in-service training that Children's Division provided that meets CCDF requirements.

- Once new regulations go into effect, child care providers will be monitored. Educare will follow up with the child care providers to work on issues addressed in the monitoring.
- The question; How do we weave social/emotional training into normal trainings.
  - Staff do not find social/emotional training title's interesting.
  - If staff could realize the small and normal things they do could have social/emotional activities built into, they might better understand (activities while feeding, changing a diaper, simply rocking a baby)

#### **Refining the recommendations and getting outside our jargon heads**

- Three different charts were on the wall. Small groups wrote out things from their discussion for a larger group discussion
- <u>Unnecessary/Un-needed Chart</u>
  - The idea it's too hard
    - Too many time people do not think something can happen because it is too hard. We all need to let that go.
  - Analysis Paralysis
  - Fear of Failure
    - Things are not going to be perfect. There will be a learning curve with any new product or policy. Errors can be corrected when identified. It shouldn't stop innovative ideas from coming to fruition.
  - $\circ$  Things not working
    - Need to let things go that do not work.
  - Silo approach
  - o Release control
    - Too many organizations what to do things their way and only their way.
- Brand New/Game Changer Chart
  - o Add social/emotional talking points
    - By creating talking points, those who create training or created training can add social/emotional training topics into those trainings.
    - This would help guide future trainings and add small amounts of material in current trainings where the trainings do not need to be redone.
  - Create a marketing plan
    - Businesses build up interest and excitement about changes. Maybe policy changes can learn from these campaigns.
  - One stop shops
    - Everything should be available in one area instead of jumping from resource to resource.

- Existing Resources Chart
  - Virtual Lab Schools
    - Military uses them. As the public, cannot use to track, but useful information is available.
  - Current organizations (Child Care Aware, United for Children)
  - Current curriculums: Basic Knowledge Curriculum: Infant/Toddler, Basic Knowledge Curriculum: Early Childhood, Basic Knowledge Curriculum: Youth Development, A Place for All Children, Preventing Child Abuse and Neglect (PCAN) from Zero to Three. Others?
  - State Departments
  - Use training organizations that provide free material.
  - Higher Ed needs to be part of our discussions
