Carol expressed preference to wait a while before appointing a co-chair.

- ➤ Clerical assistance; Daryl reported he discussed the matter with DSS fiscal—there would be certain guidelines in play regarding seeking this poetical help. Daryl will first being drafting a potential job description to see if Cindy Morff may be able to assist in some of the areas—Daryl rerated Cindy has always been helpful and nice to work with, but that he will examine whether the potential job description could be assisted by her within her CBEC-committed hours.
- ➤ The MO Budget Project: Daryl reported he talked with Amy Blouin, Exec Dir of MO Budget Project. Amy informed Daryl of potential ballot initiatives her agency was working on, and inquired about CBEC's potential as a partner in efforts around early childhood in the state.
