- Benefits and barriers for Endorsement Process
CBEC asked for ECMH workgroup analysis of benefits and barriers. Patsy will send out what we had identified before so that we can review and update before providing to CBEC
- Draft outline of a curriculum for medical professionals
Group reviewed, noted this will be an ongoing agenda item as we develop the webinars
 - CME requirement

 - HC&Y needs to be updated*

 - Part II broken up between diagnoses and partnering (do a case conference)

- Ad hoc data report on inpatient admissions and pre and post admission mental health services for youth under 6 receiving Medicaid

- Data on rates of EPSDT screening in the state
Mariann led on a discussion on the data provided, see highlights below. Group agreed this should be an agenda item for future meetings with potential to recommend that HC&Y screen be revised.
 - Participation Ratio Benchmark is 80%
 - MO is at 75%
 - Only 4 states have hit the benchmark
 - Categorically Needed =CN, Medically Needed =MN
 - Add as ongoing agenda item
 - F/U for Corrective treatment in other areas besides dental, particularly mental health
 - How did we track this data...who is doing the screenings

- Legislative recommendations
Patsy noted there will be other opportunities to shape the dialogue with the Governor's office regarding Early Childhood mental health priorities
 - Emphasis on research, give numbers (CSEFEL website), impact on future health and functioning
 - Teacher education (social and emotional competency project) Sanaria to talk with Carol Scott for approval
