Welcome and Introductions

Welcome & Announcements

- Susie/Shelley – Shelley and Susie held a third training for the two cohorts for mental health providers working with children. There were 12 participants at the training. Many initial participants have moved on from their original employers, so it is difficult to invite them to participate. Shelley and Susie believe the participants need additional training through their career. They have a good concept, but on-going training is beneficial.
- Cindy Reese/DHSS – The current grant through ECCS/HRSA – ECCS Impact. Very competitive and does not include for things like the Parent Leadership Advisory Council. The announcement on grant winners will be July 1, 2016.
- Julie– Physicians for Mental Health conference at the Governor’s Office Building. The focus is on the importance of social and emotional screening in their practice.
- Susie – Springfield completed the Triple P training. Burrell received a small grant to fund parent cafés in Springfield. The grant will pay the facilitators.
- Angie – DECA trainings are happening in and around KC area.
- Stephanie Chandler – The five inclusion specialists work with about 180 children (numbers from last year). Of all children, 85% are referrals due to behavior.
- Mary Chant – MCCA Conference and Training – November 9-11 in Springfield, MO. Calls for Presentations - submit ideas for conference presentations.
- Ann – Sesame Street is currently working on developing trauma training.
- JoAnn – Working on the Conference for the Young Years. They are looking for Social and Emotional trainings. Deadline to request to present is July 1, 2016.
- Justin – CBEC workgroups (Early Care and Education and Home Visiting) are working on finalizing recommendations to present to the board in the October meeting.

- Missouri Infant Mental Health Association – A meeting to develop the strategic plan will take place on August 26th. The 501(c)3 paperwork is submitted and awaiting for approval. The association is looking for donations.

Professional Development and Building Capacities

- Ann believes we should create a one-pager with common language that builds awareness and calls to action.
- The document will need a section that describes signs and indicators that may require a referral to a mental health consultant.
- Make a list of definitions from the mental health consultation.
- Explain why the professional development is important.
- Provide an age group (birth – 5 or birth – 8).
- Emily has a presentation that she will share that may help develop the document.

Training Collaborative

- The training is expensive and we need to develop a sustainable process.
- The idea to create an on-line training was discussed.
- Shelley believes the consultations need to continue (case studies and monthly calls).
- We will look into developing the on-line training and then search for funding for the consultations.

Social and Emotional Trainings for Child Care Providers

- Determined we need trainings on Biting, Tantrums, Trust, Relationships, Reading Cues, temperaments, and overall Basics to Social and Emotional trainings.
- Our challenge is to get the trainings approved for clock hours.
- Plan to create an Introduction to Social and Emotional Training by the August 15th meeting. Susie will send a PowerPoint to begin creating the training. Stephanie will help create into an on-line training after she receives training on the system.

Review Early Childhood Summit Ideas & Discussion

- Continued discussion regarding the early childhood summit.
- Need to identify a facilitator that can inspire, motivate and inform
- Develop a state wide action work plan/action plan.
- This could then lead into regional dialogue about what it would look like locally and advance through ECCS teams.
