➤ CFSR Round 3 Wrap-up and Data Summary – JoDene Bogart

- Discussed PowerPoint
- Round 3 timeline discussed. July 2017 was the onsite review. PIP was approved in October 2018 and implementation in November 2018. Finished the non-overlapping period on April 30, 2022.
- Quick Summary
 - Safety Outcomes 1 and 2. Quarter 6 was the first opportunity to submit to prove benchmarks. Outcome 1 we did meet the benchmark and saw an increase of 16-17%. It was about the same for Outcome 2. There was significant progress.
 - Permanency Outcomes 1 and 2. Items 4-11 make it up. Permanency Outcome 1 was the struggle. Started at 19% and ended at 25%. Outcome 2 began at 47% and ended at 52%.

- Items 4 and 5 benchmarks were not met. Fiscal penalties were imposed and will be until we meet in Round 4.
- Permanency Outcome 1 Item 4 was benchmark of 83% and highest was 76%. Item 5 benchmark is 64% and ended at 57%.
- Well-Being has three Outcome sections including items 12-18. Majority of well-being outcome 1 were met fairly early on.
 - Well-Being Outcome 2 is educational services. Missouri performs high on this outcome.

➤ Dates for CFSR Round 4 – JoDene Bogart

- Round 4 will occur July 24-28, 2023. Because Missouri is in fiscal penalty we were identified to go during the first year.
- Kansas City will be the host as the largest metro area. There will be two additional sites.
- Statewide assessment will be due late spring 2023 (May/June). Work will begin soon.
- Data Profile measures will be used to determine substantial conformity. More emphasis on data profile measures during round 4.
- Increased emphasis on equity and disparity.
- More involvement with court partners
- Minor changes to the case review tool.
- Missouri will be using the federal online monitoring system to do reviews during round 4.

➤ CFSR Data Profile Measures – Bahu Gilliam, ACF

- It is about starting conversations. Data profiles come out 2 times a year. Use AFCARS and NCANDS data. Data profile is aggregate data. Supplemental uses disaggregated data. Resources are included as well.

- Risk standardized Performance is used to compare to national data. It is a formula used to compare. Arrows indicate whether the state wants to be above or below the percentage.
 - Discussion of how to read and interpret the information in the Children’s Bureau report.
 - Discussion of the Supplemental Context Data-it is disaggregated. Discussion on how to interpret information and use it to begin discussions to evaluate reasons behind the data. Cross reference this information with information from the courts regarding number of referrals, number accepted, and number denied.
