- Finance Committee:

Missouri Office of Prosecution Services (MOPS) submitted a funding proposal for their **Family and Sexual Violence Conference in Columbia from 5/21-23**. This is their 18th Annual Conference and we funded the same last year, for the first time. MOPS seeks funding for 25 scholarships to attend for individuals who would not otherwise be able to attend the event. They clarified that the actual tuition cost was \$250 and not the \$287.50 per attendee as reflected in the grant request, which makes the scholarship request \$743.25. This amount multiplied by the 25 scholarships sought totals \$18,581.25. The original request for funding was for \$19,518.75. The request was scored by all six members of the committee, with an average score of 92.2/100. With the subsequent clarification of tuition costs, **the committee recommends funding this request in the amount of \$18,581.25**. Approved

Missouri Office of Prosecution Services (MOPS) submitted a funding proposal for their Statewide Trainings of MDTs, consisting of up to 16 dates in 4 regions of the State. The request is not specific about the dates and locations of trainings, but 5 had already been scheduled. The proposal sought \$7,844 in funding. All six members of the committee scored the grant proposal, with an average score of 93.3/100. The recommendation is to fully fund the request for \$7,844. Approved

Missouri Office of Prosecution Services (MOPS) seeks funding for the Child Sexual Abuse Trial School to take place 9/17-19 at a location now in Columbia, MO at the Stoney Creek. They initially sought \$25,025 for the costs associated with this multi-day training for up to 65 individuals who are members of the MDT. All six members of the committee scored the request, with an average score of 97.8/100. Amendment to original due to addition of location about additional costs. Addendum discussed and approved. The recommendation is to fully fund the request in the amount of \$26,130. Approved

Missouri Juvenile Justice Association (MJJA) submitted a grant application for the **Handle With Care Missouri** program. The Task Force approved funding in 2022 for the development of the website and initial start up of the statewide initiative. They service is currently available in 8 counties. Their current funding expires 1/31/24. They seek funding to cover a gap in funding between 2/1/24 and 9/20/24 for the School Response Coordinator position. Title II funds will be available to fund this position beginning 10/1/24. The request is for \$44,745 in funding, which is mostly salary and benefits for this position. All six members of the committee scored the request with an average of 97.7/100. **The recommendation is to fully fund the request in the amount of \$44,745. Approved**

Missouri Juvenile Justice Association (MJJA) seeks funding for their 2024 MJJA Spring Educational Conference 5/15-17 in Springfield. The requested amount of \$21,736 is roughly

43% of the total event cost and would provide scholarships for up to 40 individuals and to pay one speaker fee. Five of the six members of the committee scored the request with an average score of 95.4/100, with one committee member abstaining. The recommendation is to fully fund this request in the amount of \$21,736. Approved

Missouri KidsFirst submitted a proposal for funding the ChildFirst EX: Expanded Forensic Interviewing Training (with Train the Trainer) 4/16-18 in St. Louis. The request is for \$16,218 which represents the expected total cost of the training, including proposed travel stipends, for up to 9 individuals to attend. Five of six members of the committee scored the request, with one member abstaining, and yielding an average score of 99.2/100. The recommendation is to fully fund the request for \$16,218. Approved

Children's Mercy-KC submitted a proposal for \$189,926 for needed updates to the Child Protector App, previously funded in part by CJA Task Force. In 2017, the Task Force funded \$49,163 in conjunction with the CJA Task Force in the State of Texas for the development of the Child Protector App. The applicant seeks to add new and updated content to the program and to "modernize the hosting platform", which is to say that it would become a "progressive web app versus a mobile app." They propose 15 new animations and 30 new images, along with updates on the current best medical information about bruising, among other changes. The general reception of the Finance Committee was that this was a very good idea, however, due to reservations by some committee members about the amount of the request, additional information was sought and received from the applicant. Texas CJA is not going to be contributing to this update. The animation/programming/hosting have been completed by the same individuals since the inception. The subcontractors/independent contractors provided the hospital hourly rates and approximate numbers of hours for the project, which was provided to the committee. The producer of the animations has quoted \$20,710 for his services. The app developer has quoted \$140,000. Three different doctors are expected to be involved in the project with each spending approximately 100 hours in the endeavor, which makes up the other \$29,216 of the request. Discussions were had about fully funding the request, possibly requiring quarterly updates, requiring that they acknowledge that the program is funding by Missouri's Task Force on Children's Justice and possibly funding only part of the request. It was decided by the Finance Committee to bring this request to the full CJA Task Force to determine whether it would be funded.

Quorum was not made at meeting and an electronic vote was offered. Voting closed on 2/14/2024 at 12 p.m.
