SUBJECT: NEW ANTI-HUMAN TRAFFICKING WEBSITE RELEASED TO LAW ENFORCEMENT

DISCUSSION:

The purpose of this memorandum is to inform staff of a new anti-human trafficking website which has been released for use by law enforcement agencies statewide to notify the Department of Social Services of human trafficking pursuant to Section 566.223 RSMo.

The Department may utilize this information to coordinate with state, federal, and local agencies to evaluate appropriate services for victims of trafficking. Such services may include, but are not limited to: case management; emergency temporary housing; healthcare; mental health counseling; alcohol and drug addiction screening and treatment; language interpretation and translation services; English language instruction; job training; and, placement assistance.

The Division's primary involvement will be focused on those situations which present allegations of child abuse/neglect and/or circumstances in which children have been taken into protective custody.

It is recommended that field administration and/or designated staff share the enclosed link (<https://dssapp.dss.mo.gov/ReportMOHumanTrafficking/>) with their local law enforcement agencies, and discuss collaborative efforts of the multidisciplinary team in response to these types of cases.

Representatives from Central Office will communicate directly with Circuit Managers and/or Regional Administrators upon receipt of information from law enforcement agencies.
