#### Be Ready to Report Online - Create Your Account Today!

Mandated reporters are encouraged to report child abuse and neglect through the Online System for Child Abuse & Neglect Reporting (OSCR).

To create your account follow these steps:

#### STEP 1: Create Your MO Login

#### Who is a mandated reporter?

Members of specific professions, including teachers, social workers, and physicians, are legally required to report to the hotline and are classified as mandated reporters. For a full list, refer to RSMo 210.115.1.

Avoid wait time on the Child Abuse and Neglect Hotline to report issues.




### **RESPONSE PRIORITY**

**Level One:** Also called emergency reports. All victim children must be seen within three (3) hours.

#### Level Two: All victim children must be seen within 24 hours.

Level Three: All children must be seen within 72 hours.

SAFETY



### VERIFYING SAFETY OF CHILDREN

- Worker will assure the safety of the victim child(ren) in person, face to face within the response priority timeframe.
- Worker will interview the child in a safe place and alone (if possible).
- Worker will verify safety of non-victim child(ren) within 72 hours.

#### USE OF MULTI-DISCPILINARY TEAM MEMBER (MDT)

- The Children's Division (CD) may use an MDT member to assure safety.
- The MDT member should be aware of the reported concern and have the ability to assess whether the child will be safe until CD staff can make contact.
- MDT members include, but are not limited to law enforcement, juvenile officer, physicians and other medical professionals, relevant school officials, and service providers.

### ASSESSING NEEDS AND SERVICES

During the assessment or investigation period, workers will assess if the family would benefit from services such as:

COMMUNITY RESOURCE REFERRALS	PUBLIC BENEFITS
Substance Abuse Treatment	Daycare
Mental Health Treatment	Housing
Medical Care	Transportation
Dental Care	Utility
Parenting Classes	Clothing
Vocational/ Educational Assistance	Food Back

### PROTECTIVE CUSTODY (PC)

Sometimes the safety of a child can not be assured, the child can no longer remain in the home or a safety intervention did not eliminate the threat of harm.

The Children's Division can request that a child be taken into Protective Custody by making a referral to the Juvenile Office.

#### SAFETY

The Children's Division must have a court order placing the child into protective custody to place a child in an alternative care setting.

### CONCLUDING A HOTLINE REPORT

Section 210.145(15), RSMo. requires CD to complete all investigations within 45 days. In substantiating a finding of child abuse and neglect, Preponderance of the Evidence is found.

#### SAFETY

"That degree of evidence that is of greater weight or more convincing than the evidence which is offered in opposition to it or evidence which as a whole shows the fact to be proved to be more probable than not." (§210.110.13, RSMo)

### CENTRAL REGISTRY

The Central Registry is contained within the Division's Information System.

- It contains only those persons where the Division's finding is "preponderance of evidence", "probable cause" or "court adjudicated."
- The Central Registry includes the names of individuals who have pled guilty or been found guilty of crimes found in Chapters 565, 566, 567, 568, and 573, RSMo. (See Section 210.110, RSMo. for the specific crimes).
- Placement on the Central Registry is forever.



### FOSTER CARE POLICY

- HB737 was signed by the Governor this week. This bill modifies provisions related to the protection of children. This legislation guarantees federal benefits are securely allocated to individual beneficiaries currently in the foster care system to help establish future financial stability. A scope of work is being finalized to go out for bid through the procurement process.
- HB121 was signed by the Governor this week.Part of this legislation establishes the Zero-Cost Adoption Fund to support families during the adoption process with non-recurring expenses and post-adoption assistance. DSS is beginning work with the Department of Revenue to work on establishing the fund.



### TRAINING

- Training is now under new leadership
  - Pam Alston, Assistant CD Director
  - Shawn Boyd, Assistant Deputy Director
  - Annie Wilson, Training Unit Manager
  - Training Unit consists of 1 Supervisor, 16 Trainers and 2 Clerical
- We will be going back in person with a target date of Sept 1, 2025
- Looking at regional placement of training with centralized curriculum
- Basic training will be a total of 7 weeks not counting E-learning, OJT, and other needed training such as Trauma, Legal Aspects and Human Trafficking
- Supervisor Training being developed including clinical supervision training to begin January, 2026
- Adding VR technology to help staff with skills in interviewing

#### FIELD OPERATIONS

### FEDERAL CASE REVIEWS

- Missouri's CFSR Measurement Plan requires 40 CFSR case reviews each quarter
- Six dedicated Quality Assurance Practice Improvement (QAPI) staff members complete 80% of the reviews
- QAPI staff, Children's Division Field Operations Specialists, and FCCM QA designees and one FACES unit team member also complete reviews
- Each case review requires several levels of approval before finalization, including review by Children's Bureau
- Oversight by Children's Bureau has been reduced from 75% in July 2024 to 25% beginning in August 2025
