Box 853 Jefferson City, MO 65102-0853 The Director shall inform each eligible diaper bank of its share of the apportioned credits no later than thirty (30) days following July 1 of each fiscal year. Within thirty (30) days of any reapportionment, the Director shall notify those diaper bank's that would be affected by the reapportioned tax credit. The Director will consider comments the diaper bank's submit concerning planned future uses of the agency's tax credit allocation prior to the end of the thirty (30) day period. The Director's decision regarding reapportionment shall be final. Once an agency has been certified by the Department of Social Services, the organization's name will be added to the list of agencies that are eligible for the Diaper Bank Tax Credit. Agencies must submit application for recertification annually. All incomplete or inaccurate applications will be returned to the Diaper Bank.
