- VOCA staff will enter the data into the PMT system by November 15th, 2025.
 - Agencies will be reporting numbers (not zeroes) for Q4 – the report will be completed as normal, including the final narrative.
 - **Note:** If your agency is using Fund Balance funds, leave the Q4 report blank, complete the final narrative, then complete the GR Q4 report. We will email the due dates and reports for completion to everyone.

State GR Reports Q1, Q2, Q3

- Due no later than September 19th.

6-month Extensions (October 1, 2025 – March 31, 2026)

- Due no later than September 30th.
- 46 out 177 have been received.
- Signature page will be sent after the VOCA award letter has been received by the state. Must be received by September 30th, per the VOCA Rule.
 - The signature page with the updated VOCA terms and conditions will be sent out with the 6-month Contracts even though GR is being used.
