To get those back to us, once you send us the signature page procurement will release the finalized contract to you.

Then the Voca staff will send you your budget forms and your to be filled out and send back to us.

Just a side note, if you do not get those back to us and we do not get the budgets approved, you cannot invoice for April to us.

So if you can return those promptly, that would be amazing. Thank you.

February billing.

So it's actually March billing is due April 15th.

Training.

Approval request. You can now send those for training approvals for anything from March to June. You can send those in.

Movers.

I everybody but five agencies are in that spend authorize either myself or movers has sent emails out. So movers has sent an e-mail to you. So you might look if you're not in spend authorized.

And then I tried to send some emails out to everyone as well as a reminder.

To look at your e-mail, because apparently they cannot approve you, they must need something from you.

Quarter 2 reports for January 1st through March 31st are due by April 30th.

As a reminder, everyone used general revenue funds, so the reports will be all zeros.

And your victim served will go into the comment section at the bottom of the report.

Please don't forget to sign and date your report when you send it to us as well.

April is child Abuse Awareness Month. If you have something going on at your agency or something for those and you want us to put the information out there, please feel free to send us your Flyers or whatever you have.

Also, April is sexual Assault Awareness month.

So if you have something going on for that as well, please send it to us.

April is also crime victims rights.

It's week, which is the 6th through the 12th, which is next week.

DPS is having their Missouri victim Services Academy in conjunction with the crime

Victims Rights Week, so that's next week 7th and 8th.
