#### CASA of Southwest MO

- Laura Farmer
- Office located in Springfield
- Served roughly 2500 children in 2023
- Past year opened the CASA Clubhouse
  - O Activity center designed to fill the gaps between children in the foster-care system
  - Way to serve more children while trying to build funding and recruit more volunteers to serve more children
  - o Welcoming environment for children where they can become acquainted
  - Case worker uses offices to help find placements for children (trauma-informed)
  - Host supervised family visits
  - o Life skills classes for teens in foster care
  - o Kids closet where they can find comfort and hygiene items
  - o CASA volunteers and kids can hangout and participate in the classes
  - O Hosting in partnership with Juvenile Office, team court hearings take place where judge sits at conference table with teens and other parties to help start conversations and enhance the services that are provided to them

- Served 2000+ children with the CASA Clubhouse

- Est. 1991
- Secure shelter site with 32 beds and an outreach office with a shrift store
- Built larger shelter in 2019 serve 200+ individuals a year there
- Serve all genders
- MOCADSV conference presentation on DV services
- Counseling, case management, court advocacy, financial literacy, housing, etc.
- Partnership with local law enforcement, currently 2 classes running
- Youth violence prevention program sponsored by United Way
- Serve about 400 clients a year
- Food pantry and hygiene closet
- 2 upcoming events, annual luncheon on Aug 28<sup>th</sup> and fashion show fundraiser in Oct

- Est. in 1994
- Court advocacy, case management, SA advocate, therapy, etc.
- 3 prisons and 5 hospitals in the area, advocates work with those facilities
- Outreach program continues to grow community offers supportive services
  - o Clothes, food, education, etc.
- Sell 100 raffle tickets for \$100, winner gets \$5,000 and agency gets \$5,000
  - o No struggle getting rid of tickets, live drawing on FB and local radio station
- SEMO Family Violence Counsel websites will provide information on upcoming events/needs/successes
- 2 trivia nights a year, successful fundraiser
- Local churches will do little drives and donate to local agencies for victims
- Partnered with local banks for Purple Pledge (way to collect funds from individuals who can't attend fundraisers or events but are still wanting to sign-up to donate to the agency auto-transfer of funds from individual to agency)
