## **Review of FFY 24 LIHEAP State Plan:**

  - Winter EA program will run from October 1st to May 31st.
  - State of Missouri will no longer have a designated cooling program. However participants can still select to have Electricity paid with EA regardless is cooling charges.
  - o ECIP will still run from November 1st to September 30th
  - Cooling EA funding has been changes to 0% while Winter EA has increased to 50% of the budget. All other allocations have not changed.
  - Eligibility determination has not changed.
  - State of Missouri is maintaining the eligibility standard of 60% State Median Income (SMI)

  - o EA payments will be reduced by 50%
  - o Elderly & Disabled clients will still be able to apply for EA starting October 1st
