MISSOURI MEDICAID ON-LINE FEE SCHEDULE

Missouri Medicaid fee schedules through the Division of Medical Services are now available at <http://www.dss.mo.gov/dms>. The on-line fee schedules will identify covered and non-covered procedure codes, restrictions, allowed units and the Medicaid allowable fee for each unit. The file is updated quarterly and intended as a reference not a guarantee of payment. Please refer to the program specific Medicaid provider manual and bulletins for benefit and limitations. Paper copies of the fee schedules are no longer available.

The on-line Fee Schedule allows for the downloading of individual files or the search for a specific fee schedule.

Some procedure codes may be billed by multiple provider types. Categories within the fee schedule have been set by the service rendered and are not necessarily provider specific.

Programs such as Federally Qualified Health Centers, Rural Health Clinics, Hospitals, Nursing Homes, etc., not paid via a set fee schedule, but paid a percentage, per diem rate, etc., will continue to be paid in that manner. If you are a provider paid in this manner disregard the fee listed in the fee schedule.
