



## MO HealthNet Billing Instructions for Screening, Brief Intervention and Referral to Treatment (SBIRT) Services

MO HealthNet Division (MHD) reimburses Primary Care Health Home Provider organizations for Screening, Brief Intervention and Referral to Treatment (SBIRT) services performed by certified staff under the supervision of a physician or nurse practitioner. Certification is required in order to be recognized as an eligible provider for reimbursement of SBIRT codes by MHD.

The Missouri Institute for Mental Health (MIMH) conducts three types of training for SBIRT services. The first type consists of online training courses necessary for a non-clinical staff member to become certified to provide "Screening". The second training is for "Brief Education/Intervention (ASSIST)" SBIRT services. The third type of training is for licensed substance use disorder and/or mental health professionals to provide additional services in the form of "Brief Coaching" for patients with a higher level of risk, but who are not yet dependent or addicted. Upon successful completion of each training course, a certificate is issued by MIMH. It is the provider's responsibility to keep this certification on file.

Only trained staff at a Health Home clinic (or clinic site connected to the Health Home "administrative site") may perform SBIRT services, however since most individuals who perform the initial pre-screen and ASSIST are non-clinical and not enrolled as MO HealthNet providers, the clinician (physician or mid-level provider) providing other services during a visit may bill as the performing provider for the pre-screen or ASSIST SBIRT codes. Only licensed behavioral health consultants or licensed substance use disorder professionals who have completed MIMH's training for "Brief Coaching" can perform and bill for that SBIRT service.

Health Home providers may bill SBIRT codes for MO HealthNet participants that are 18 years of age and older; these services are not limited to Health Home participants. *MO HealthNet requires the CRAFFT Screening Tool for participants 13 – 17 years old.* This screening consists of a series of 6 questions developed to screen adolescents for high risk alcohol and other drug use disorders simultaneously. It is a short, effective screening tool meant to assess whether a longer conversation about the context of use, frequency, and other risks and consequences of alcohol and other drug use is warranted. This version of the CRAFFT is intended for use by a trained clinician as a brief interview with an adolescent patient. The CRAFFT 2.1 and 2.1+N are also now available which includes vaping and edibles as methods of administration of marijuana. The CRAFFT 2.1+N includes the Hooked on Nicotine Checklist to address nicotine and tobacco use. Health Home sites must log the time used for SBIRT services separately from established Health Home PMPM duties, and staff that spend 100% of their effort on the health home initiative may NOT bill for any SBIRT services provided nor can a clinician performing provider bill for services performed by anyone whose FTE is 100% bill for these services.

Federally Qualified Health Center (FQHC), Rural Health Center (RHC) providers, and Community Mental Health Center (CMHC) providers must use their MO HealthNet clinic provider (50) number for the billing provider for SBIRT services on a CMS1500 medical claim form. Please note the FQHC/RHC/CMHC amounts to be used for billing are on the attached fee schedule. Any claims billed for more than MHD's allowed amount will be recouped.

NOTE: Certification is required only for those individuals who are billing for (or are using a clinician performing provider to bill for) SBIRT services. ALL individuals performing SBIRT services must complete the online training for screening and brief intervention to receive their certificate. The website to obtain

training is <u>esbirt.org</u> and click on the "training preview" tab and register for the training. Only licensed behavioral health consultants or licensed substance use disorder professionals need to complete MIMH's training for "Brief Coaching" so they can bill for that SBIRT service. There is a fee for "Brief Coaching" certification which is currently \$100 that covers peer review and feedback by Behavioral Health Consultants.

ALSO NOTE: Only individuals who work in a clinic site affiliated with a MO HealthNet health home organization can bill for SBIRT services. Claims from providers at other organizations will be rejected.
