The Medicaid agency must obtain disclosures from disclosing entities, fiscal agents and managed care entities (MCOs, PIHPs, PAHPs, and HIOs), except PCCMs are required to disclose upon Medicaid agency request. The report shall be submitted in the format specified by the state agency in the “Ownership or Controlling Interest Disclosure” and “Transaction Disclosure”.

The MCOs shall update ownership and financial disclosures information on an annual basis, per Missouri Managed Care Contract Section 2.21.5. This report shall include full and complete information regarding ownership, financial transactions, and persons as described herein.
