Public Transit/bus token/pass	Must not utilize public transit/bus token/pass when there is more than a three block walk to the bus stop (2.7.9.e)	Added - - or more than one-quarter mile (1/4), whichever is the least amount of distance (2.7.9.e)
Performance Measure (2% withhold of monthly capitation payment)	Will call pick up service require the participant to wait no more than 60 minutes from notification to the broker. Of the 2% withhold – broker would receive: 10% for 96.5% compliance; 5% for 93% to 96.5% compliance; 0% for less than 93%	Changed the 93% compliance standard to 90%.
