DURABLE MEDICAL EQUIPMENT (DME) PROGRAM

Applies to: MO HealthNet Fee-For-Service DME Providers

Effective date: June 1, 2023

MAXIMUM QUANTITY CHANGE FOR HCPCS CODE E2225 (MANUAL WHEELCHAIR ACCESSORY, CASTER WHEEL EXCLUDES TIRE, ANY SIZE, REPLACEMENT ONLY)

Effective June 1, 2023, the MO HealthNet Division (MHD) will change the maximum allowed quantity for HCPCs code E2225 (manual wheelchair accessory, caster wheel excludes tire, any size, replacement only) to two (2).

APPLICABILITY

The information in this bulletin applies to the MO HealthNet (MHD) fee-for-service program and may apply to the MHD managed care program, as well. MHD's fee-for-service policies set the basic coverage policies for benefits and limitations in the managed care program. The managed care health plans have additional flexibilities in operating their respective programs such as determining which services require prior authorization, and details required for claims submission. Certain services, such as pharmacy, are "carved out" of managed care and will be paid through the fee-for-service program.
