# PERSONAL CARE AND PRIVATE DUTY NURSING SCHOOL-BASED INDIVIDUALIZED EDUCATION PLAN (IEP) DIRECT SERVICES

**Applies to: School-Based IEP Direct Services Providers**

**Effective date: July 1, 2023**

- **Maximum Allowable Rate Increase**

### MAXIMUM ALLOWABLE RATE INCREASE

Effective for dates of service on or after July 1, 2023, the MO HealthNet fee-for-service maximum allowable rates are increased for the following School-Based IEP direct services: Private Duty Nursing and Personal Care.

The MO HealthNet Division (MHD) will reimburse the lesser of the provider's billed charge or the maximum allowable amount for the date of service billed. Services provided as documented in an IEP are reimbursed at the Federal Financial Participation (FFP) rate. The remainder of the allowed amount is the responsibility of the school district originating the IEP.

The procedure codes affected and new maximum allowable amounts are as follows:

Program Type	Procedure Code	Modifier	Rate effective July 1, 2023
Private Duty Nursing, 15 Minutes	T1000	TM	\$13.76
Personal Care, 15 Minutes	T1019	TM	\$8.14

### APPLICABILITY

The information in this bulletin applies to the MO HealthNet (MHD) fee-for-service program. MHD managed care members receive IEP services through the fee-for-service program.
