INTERNATIONAL CLASSIFICATION OF DISEASE (ICD) 10th REVISION DIAGNOSIS CODES

As required by federal law, the MO HealthNet Division (MHD) will accept only International Classification of Diseases (ICD), 10th Revision, Clinical Modification/Procedure Coding System codes on claims with a date of service (DOS) on and after October 1, 2015. Services in the Women's Health Services Program will only be covered when one of the following ICD-10 diagnosis codes is billed as the primary diagnosis for dates of service on and after October 1, 2015:

ICD-10	Code Title
Z30.011	Encounter for initial prescription of contraceptive pills
Z30.012	Encounter for prescription of emergency contraception
Z30.013	Encounter for initial prescription of injectable contraceptive
Z30.014	Encounter for initial prescription of intrauterine contraceptive device
Z30.018	Encounter for initial prescription of other contraceptives
Z30.019	Encounter for initial prescription of contraceptives, unspecified
Z30.02	Counseling and instruction in natural family planning to avoid pregnancy
Z30.09	Encounter for other general counseling and advice on contraception
Z30.2	Encounter for sterilization
Z30.40	Encounter for surveillance of contraceptives, unspecified
Z30.41	Encounter for surveillance of contraceptive pills
Z30.42	Encounter for surveillance of injectable contraceptive
Z30.430	Encounter for insertion of intrauterine contraceptive device
Z30.431	Encounter for routine checking of intrauterine contraceptive device
Z30.432	Encounter for removal of intrauterine contraceptive device
Z30.433	Encounter for removal and reinsertion of intrauterine contraceptive device
Z30.49	Encounter for surveillance of other contraceptives
Z30.8	Encounter for other contraceptive management
Z30.9	Encounter for contraceptive management, unspecified
Z98.51	Tubal ligation status
Z98.52	Vasectomy status
