- **RATE UPDATE**

MAXIMUM ALLOWABLE RATE INCREASE

Effective for dates of service on or after July 1, 2016, the MO HealthNet ambulance program maximum allowable rates for the services listed below are increased by approximately 2% plus an additional \$45 for ground base codes and an additional increase for helicopter codes. The MO HealthNet Division will reimburse the lower of the provider's billed charge or the maximum allowable amount for the date of service billed. Providers may not bill the MHD at a higher rate than they charge their private pay patients. Providers must bill their usual and customary rate.
