In addition to the procedure codes in the [March 28, 2018](#) bulletin (Vol. 40, No. 50), the following HBAI procedure codes will also be covered for dates of service on or after March 13, 2018 when provided by qualified doctoral level psychology interns.

96150	HL	AH	Limit of 3 units per rolling year, per participant.	Health and behavior assessment, each 15 minutes face-to-face with patient; initial assessment	\$16.63
96151	HL	AH	Limit of 3 units per rolling year, per participant	Re-assessment MHD defines a unit of service as 15 minutes.	\$16.63
96152	HL	AH	Limit of 2 units per day. Limit of 4 units per month and 24 units per rolling year, per participant	Health and behavior intervention, each 15 minutes, face-to-face; individual	\$16.63
96153	HL	AH	Limit of 4 units per day, and 48 units per rolling year, per participant	Group (2 or more patients) MHD defines a unit of service as 15 minutes.	\$7.79
96154	HL	AH	Limit of 3 units per day, and 36 units per rolling year, per participant	Family (with the patient present) MHD defines a unit of service as 15 minutes.	\$16.63
