The MO HealthNet Division (MHD) requires the 2020 version of the CDT on all claims with dates of service on and after January 1, 2020.

Why are we notifying you of this change?

The ADA's Council on Dental Benefit Programs for 2020 deleted certain codes. Those codes are not payable for dates of service January 1, 2020 and after. If you submit claims with those codes, MHD may recoup the paid amount. If that happens, you may resubmit/adjust claims for

proper payment using the correct 2020 CDT codes. If you have questions concerning how to submit a claim adjustment, please contact Provider Communications at 573-751-2896.
