CPAP SUPPLIES REIMBURSEMENT AND ALLOWED QUANTITY

Effective April 1, 2020, procedure code A4604NU, tubing w/integrated heating element, will be a covered service.

C-Pap supplies will be reimbursed as follows:

Procedure code and description	Allowed	Qty limit
• A4604NU- tubing w/ integrated heating element	\$38.50	1/180 days
• A7031NU- replacement facemask	\$61.84	1/90 days
• A7032NU- nasal cushion	\$35.93	1/90 days
• A7033NU- nasal pillows	\$25.18	1/30 days

PROCEDURE CODE E1028, Mounting Hardware

Effective February 01, 2020, the maximum quantity allowed for procedure code E1028NU, E1028RB, E1028NUSC, E1028RBSC, mounting hardware, has increased from a quantity of 5 to a quantity of 8. The use of procedure code K0108, misc. DME, will not be allowed.

TRACHEA TUBES

Effective April 1, 2020, the following procedure codes, will be manually priced at cost plus 20%:

- A7520NU, trach larynx tube non-cuffed
- A7520NUEP, trach larynx tube non-cuffed
- A7521NU, trach larynx cuffed and
- A7521NUEP, trach larynx cuffed and
- A7522NU, trach larynx tube stainless
- A7522NUEP, trach larynx tube stainless

An invoice of actual cost will be required with the claim for manual pricing.

APPLICABILITY

Managed Care enrolled providers should contact their Managed Care Organization for questions regarding Durable Medical Equipment billing and reimbursement.
