#### **NURSING FACILITY COST REPORT – DELAYED FILING DUE DATES**

Pursuant to Executive Order 20-04 and with the consent of Governor Parson, the Director of Social Services issued Order 20-02, which allows the MO HealthNet Division (MHD) to suspend the requirements in 13 CSR 70-10.015(10)5 and 6. Based on Order 02-02, the MHD is delaying the MO HealthNet Nursing Facility Cost Report due dates to be consistent with the Centers for Medicare and Medicaid Services (CMS) extended cost report filing dates due to the COVID-19 outbreak. Following are the affected fiscal year end (FYE) cost reports, initial due dates, and the extended due dates:
