AMBULANCE PROGRAM RATE INCREASE AND MASS ADJUSTMENTS

The 100th General Assembly of the State of Missouri approved a rate increase for specific procedure codes for MO HealthNet ambulance providers effective for dates of service on or after July 1, 2020. The maximum allowable rate for the procedure codes listed below received an increase of \$45.00. The MO HealthNet Division (MHD) must receive Centers for Medicare and Medicaid Services (CMS) approval of the MHD State Plan Amendment (SPA) prior to all provider rate changes. Until approval is received, the MHD must pay providers the approved rate as of June 30, 2020 (see that rate below). The MHD will enter the new rate and a mass adjustment of claims for dates of service on and after July 1, 2020, once CMS approves the rate increase.
