COVID-19

The MO HealthNet Division (MHD) is responding to an outbreak of respiratory disease caused by a novel coronavirus. The virus has been named “severe acute respiratory syndrome coronavirus 2” (“SARS-CoV-2”) and the disease it causes has been named “coronavirus disease 2019” (“COVID-19”).

COVID-19 VACCINE BOOSTER ADMINISTRATION PROCEDURE CODES

Effective for dates of service on or after September 22, 2021, providers may bill for the administration of the Pfizer-BioNTech COVID-19 Vaccine booster using the vaccine administration code specific to the Pfizer vaccine for the booster. Effective for dates of service on or after October 20, 2021, providers may bill for the administration of the Janssen (Johnson & Johnson) COVID-19 Vaccine booster and the Moderna COVID-19 Vaccine booster using the vaccine administration codes specific to the Janssen (Johnson & Johnson) and Moderna Vaccines for the booster. Do not bill vaccine administration procedure codes 90460-90461 or 90471-90474 for the administration of the COVID-19 vaccine.

If a significant separately identifiable Evaluation and Management (E/M) service is performed, the appropriate E/M service code should be reported in addition to the vaccine administration code. The vaccine ingredient cost *cannot* be billed to MO HealthNet.

Providers must not charge a copay for the COVID-19 vaccine administration codes.

Covered procedure codes are listed in the table below.

Procedure Code	Procedure Code Description	Reimbursement Rate
0004A	Pfizer-BioNTech COVID-19 Vaccine Administration – Booster	\$40.00
0034A	Janssen COVID -19 Vaccine Administration - Booster	\$40.00
0064A	Moderna COVID -19 Vaccine (Low Dose) Administration - Booster	\$40.00

PEDIATRIC COVID-19 VACCINE ADMINISTRATION

Effective for dates of service on or after October 29, 2021, providers may bill for the administration of the Pfizer-BioNTech COVID-19 Vaccine for children ages 5 to 11 years old using the vaccine administration codes specific to the pediatric Pfizer Vaccine. Do not bill vaccine administration procedure codes 90460-90461 or 90471-90474 for the administration of the COVID-19 vaccine.

A child will need a second shot of the Pfizer-BioNTech COVID-19 Vaccine three weeks after their first shot.

Providers must not charge a copay for the COVID-19 pediatric vaccine administration codes.

Covered procedure codes are listed in the table below.

0071A	Pfizer-BioNTech Covid-19 Pediatric Vaccine - Administration - First dose	\$40.00
0072A	Pfizer-BioNTech Covid-19 Pediatric Vaccine - Administration - Second dose	\$40.00

OUTPATIENT BILLING FOR COVID-19 VACCINE ADMINISTRATION

Hospitals may bill for the COVID-19 vaccine administration when performed as an outpatient service using the appropriate procedure codes listed above.

PHARMACY COVID-19 VACCINE ADMINISTRATION

Pharmacy providers may bill for the COVID-19 vaccine through the point-of-sale pharmacy system using the National Drug Code (NDC) that appears on the product administered.

Each pharmacy claim will receive a professional dispensing fee of \$40.00 for single-dose and multi-dose vaccines. The professional dispensing fee will serve as reimbursement for the administration of the COVID-19 vaccine. Providers must not charge a copay for the COVID-19 vaccine.

COVID-19 vaccination pharmacy claims, ordered by pharmacists, should be submitted using the pharmacist's name and pharmacy's National Provider Identifier (NPI), as prescriber. Pharmacies are also able to utilize the statewide standing order for COVID Vaccines.

Pharmacy providers administering COVID-19 vaccinations should recommend members receiving vaccines that require two doses to do the following:

- Use the same pharmacy for both vaccinations.
- Receive the second dose on the date specified by the manufacturer's product labeling.

Participants receiving a third dose or booster dose of the COVID-19 vaccine can receive the vaccine in any location.

MEDICARE/MEDICAID CLAIMS

COVID-19 vaccination claims for MHD participants who are dually eligible for both Medicare and Medicaid must be billed to the member's Medicare plan provider.

MANAGED CARE ENROLLEES

Under the current Managed Care program, the administration of a vaccine is billed to the provider's contracted Managed Care Organization (MCO). For the purpose of the COVID-19 vaccine only, the administration portion of the vaccine must be billed to the MO HealthNet Fee-for-Service program, and not to the Managed Care Organization that the provider is contracted with.

REIMBURSEMENT FOR THE UNINSURED

The COVID-19 Claims Reimbursement to Health Care Providers and Facilities for Testing and Treatment of the Uninsured Program (COVID-19 Claims Reimbursement program) administered by the Health Resources & Services Administration (HRSA) is available for reimbursement of a COVID-19 vaccine and vaccine administration costs for individuals who would not receive MO HealthNet coverage for the COVID-19 vaccine administration, see <https://www.hrsa.gov/CovidUninsuredClaim>.
