RATE UPDATE FOR DHSS-AUTHORIZED HOME AND COMMUNITY-BASED SERVICES

Applies to: Providers of DHSS-Approved Home and Community-Based Services

Effective date: July 1, 2022

MAXIMUM ALLOWABLE RATE INCREASE

Effective for dates of services on or after July 1, 2022, the MO HealthNet Fee-For-Service maximum allowable rates are increased as indicated below. These changes reflect increases that were appropriated for the Fiscal Year 2023 budget.

MO HealthNet will reimburse the lower of the provider's billed charge or the maximum allowable amount for the date of service billed. Providers may not bill MO HealthNet at a higher rate than they charge their private pay patients. Providers must bill MO HealthNet their usual and customary rate.

It is the Department of Social Services' expectation that a substantial portion of the rate increase will be passed through to the direct care worker/nurse providing direct care services.
