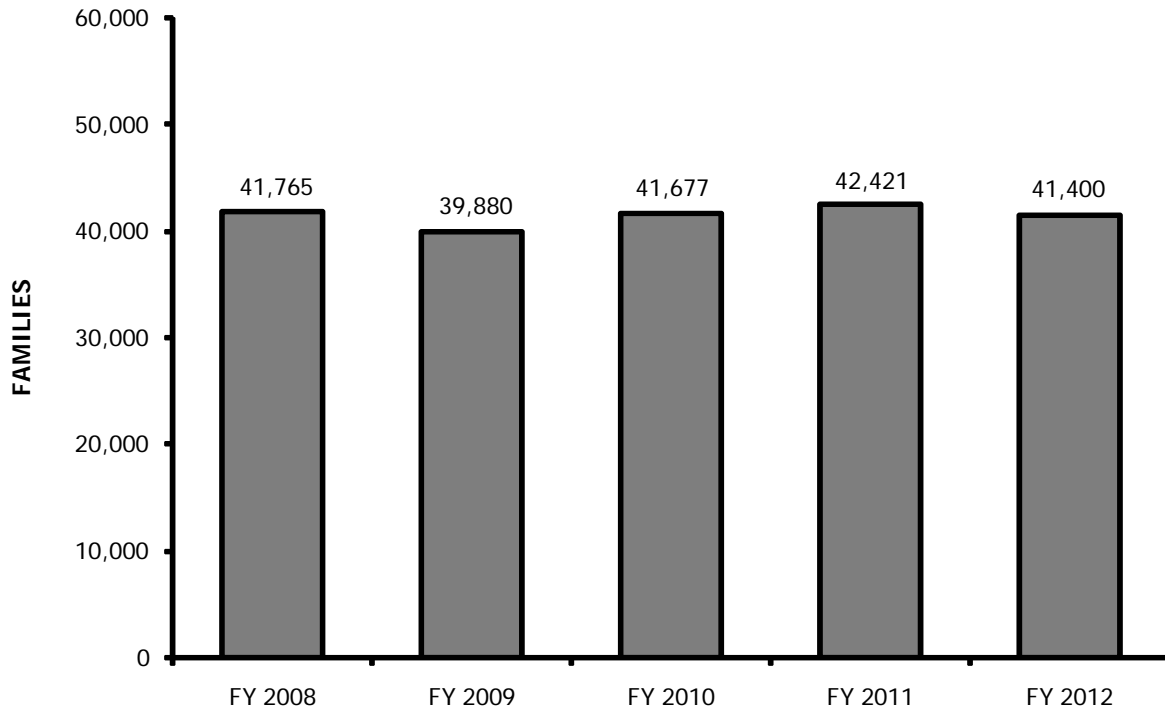

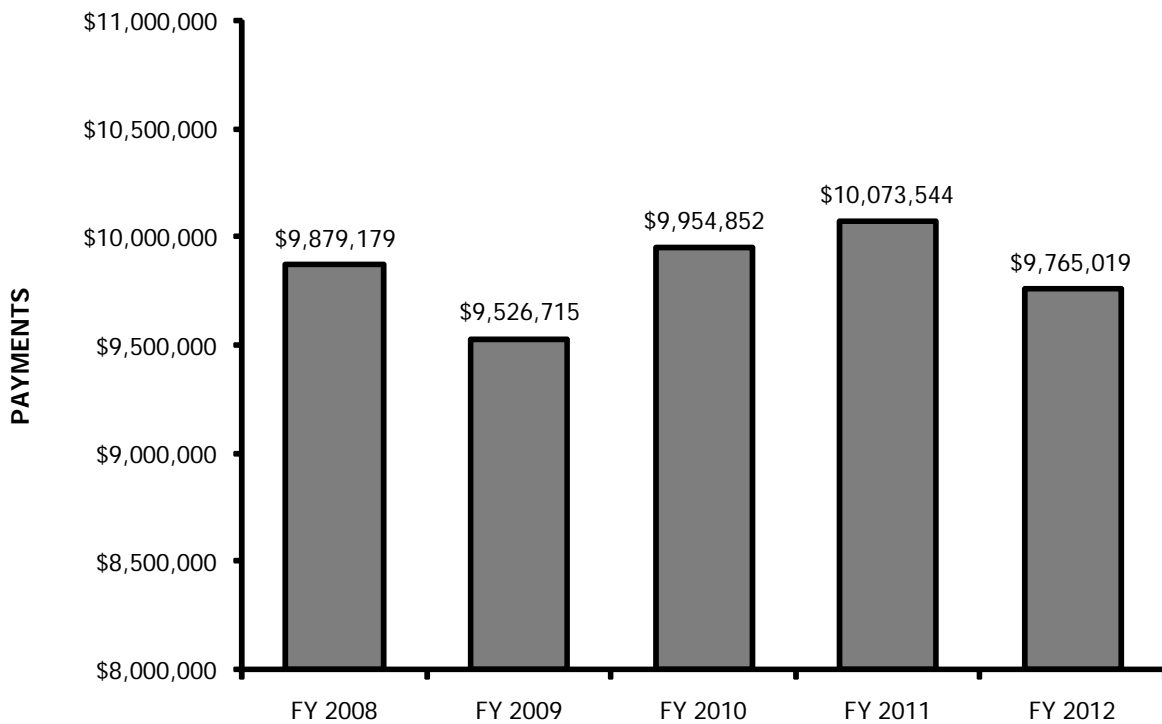

Average Monthly Caseload Fiscal Years 2008 - 2012

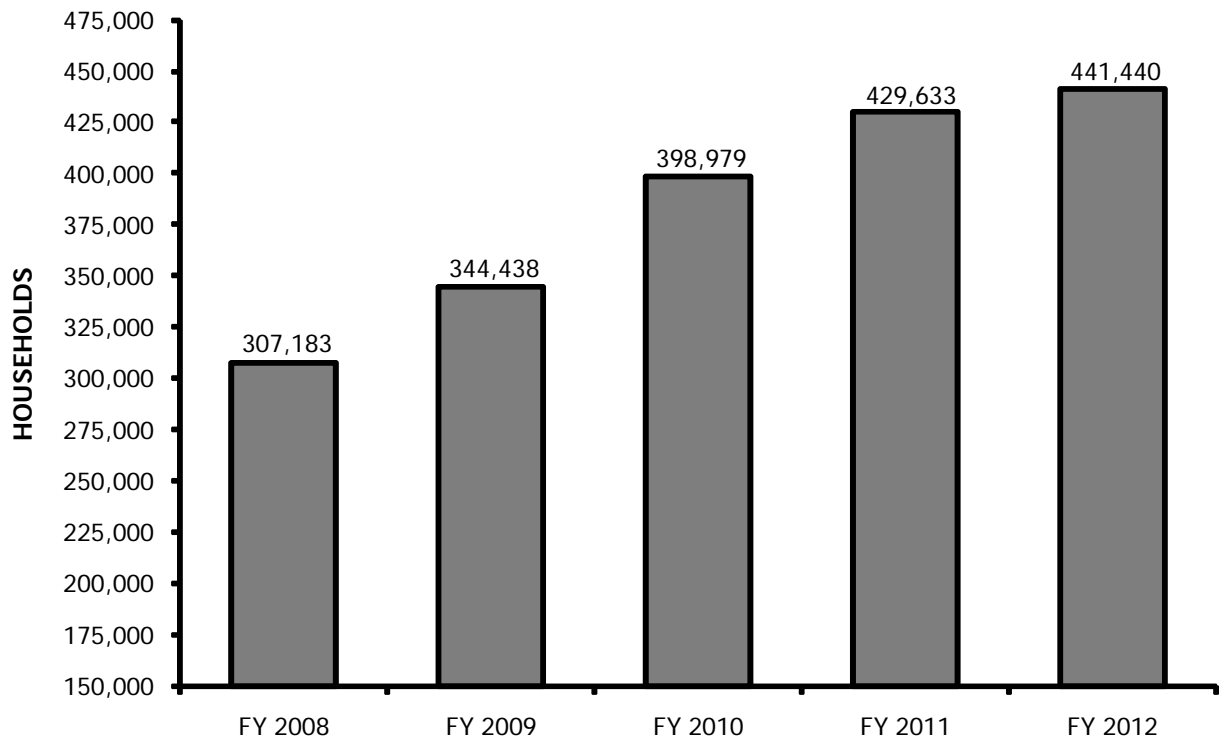
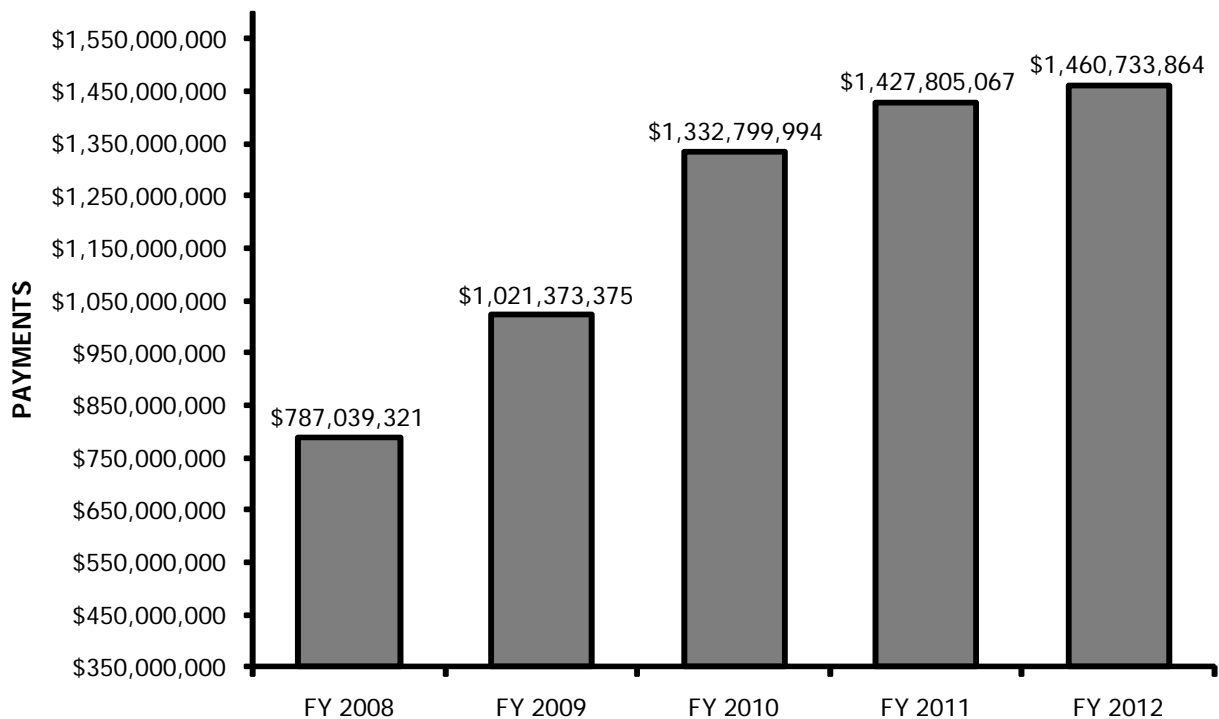


Figure 6. Food Stamps
