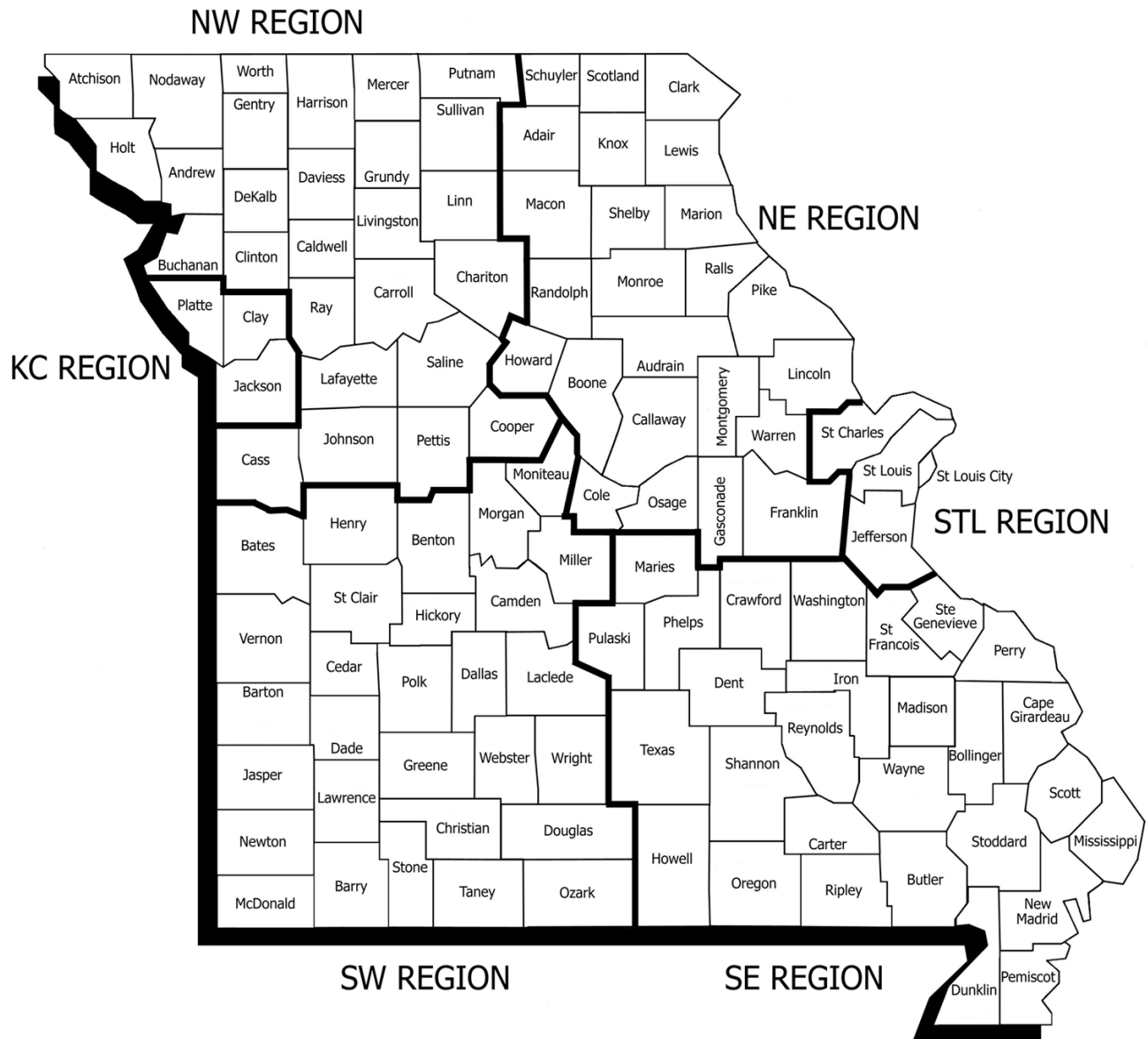

Average Monthly Caseload Fiscal Years 2002 - 2006

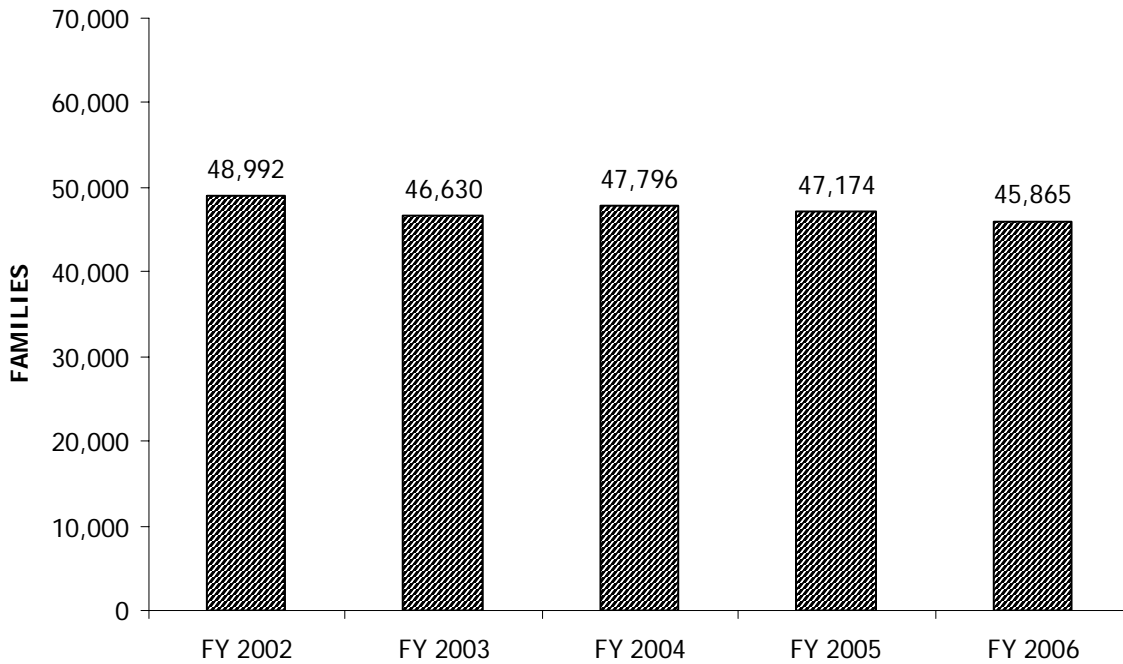
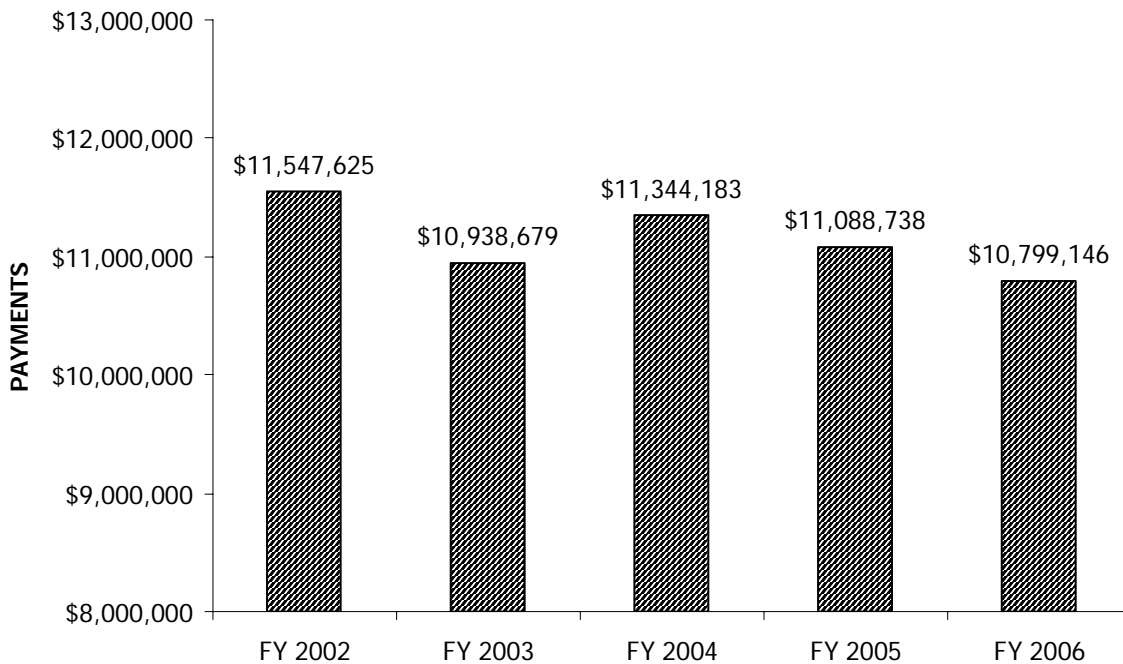


Figure 3. Temporary Assistance

Average Monthly Caseload Fiscal Years 2002- 2006

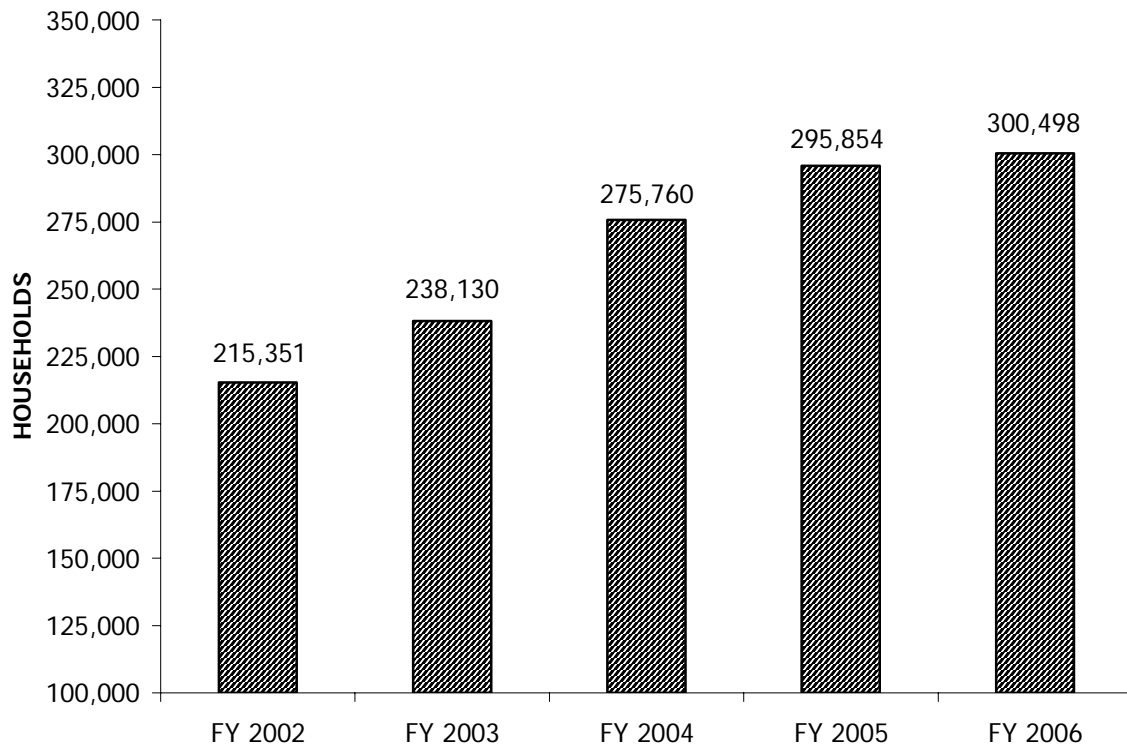
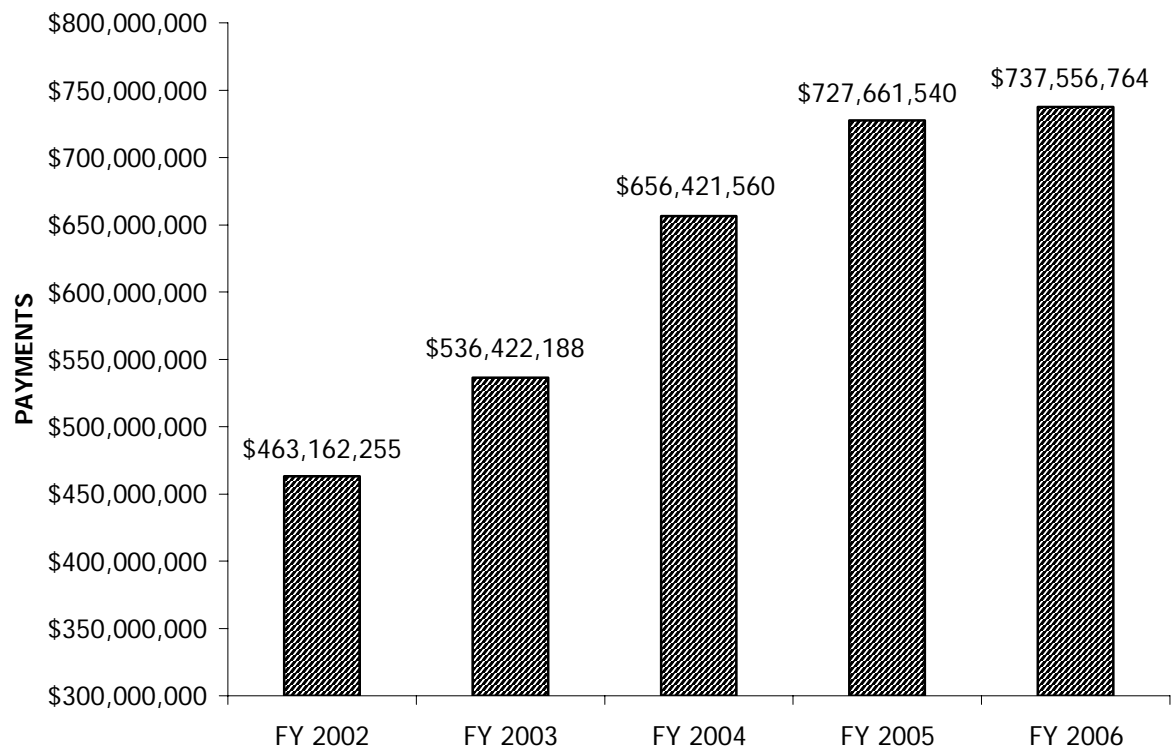


Figure 6. Food Stamps
