Part I

Intensive In-home Services Statewide Overview

Introduction

What is IIS?

Intensive In-home Services (IIS) offers families in crisis an alternative to out-of-home placement of children into alternative care. IIS is a Division of Family Services' treatment program designed to be short-termed and home-based. A specialist from either DFS or a contracted vendor provides services to the family in crisis so that the family can remain safely together. Services include individual and family counseling, parenting education, and child development training. The goal of these services is to manage the crisis and restore the family to an acceptable level of functioning.

Definitions

Families:

A Missouri family who has one or more children at-risk for removal from the home due to abuse, neglect, juvenile delinquency, or other such circumstances are eligible to receive IIS.

At-risk children:

The children identified as at-risk for out-of-home placement are referred to as *at-risk children*.

Head of Household:

Each IIS family is represented by a head of household.

Families and Children Accepted

During state fiscal year 2003 (July 1, 2002-June 30, 2003), the number of at-risk children accepted into IIS was 3,213. The total number of families accepted into IIS was 1,618 and the total number of children, including at-risk children, was 4,155. On average, families accepted into IIS were comprised of 2.6 total children and 2 at-risk children (Appendix A).

Families and Children Not Accepted

The 1,441 families not accepted for IIS during FY 2003 included 2,457 at-risk children (Appendices A and B). The most common reason (37%) that at-risk children were not accepted into IIS was due to lack of openings into the program with the children remaining at home.

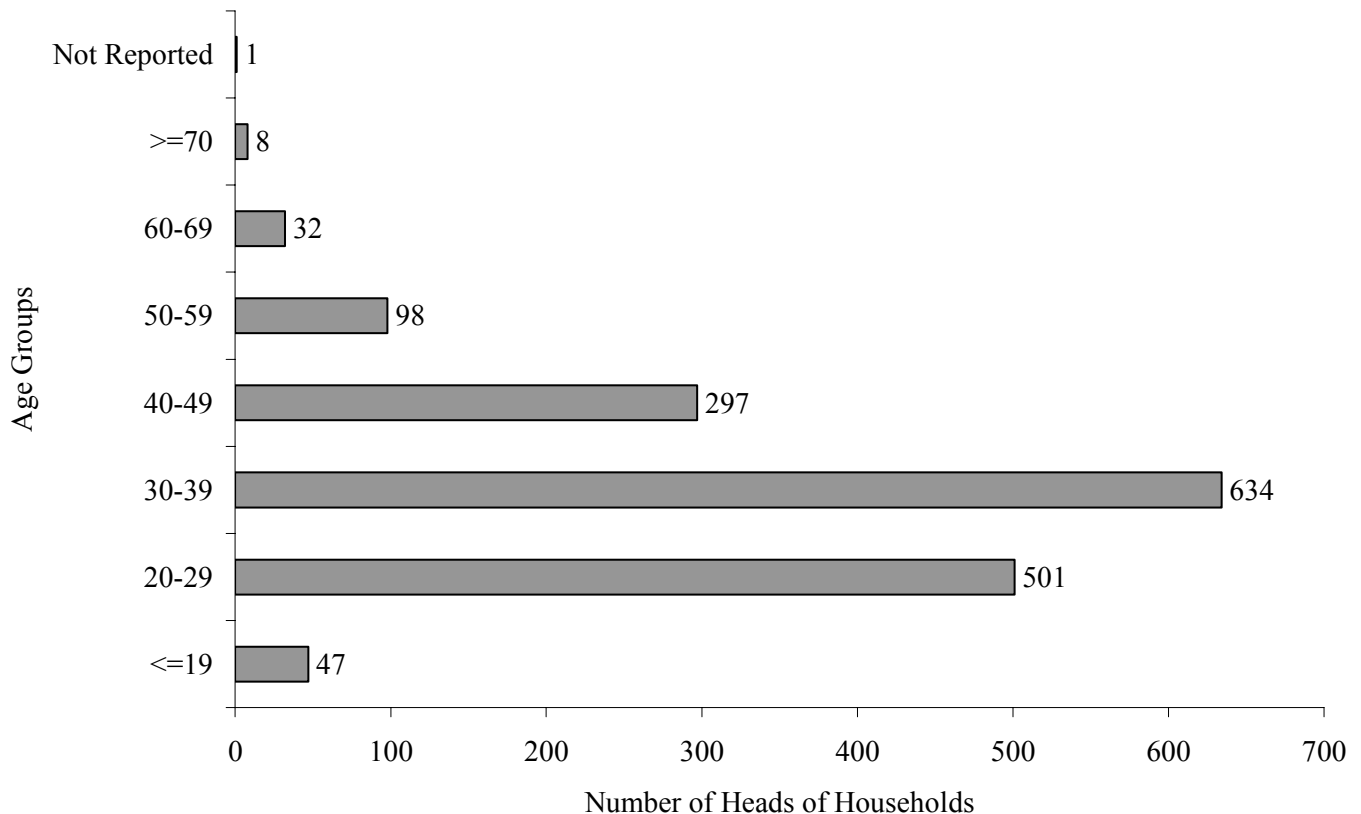

During FY 2003, the head of household was most likely to be in the age range of 30-39, female and white (Appendix D, Appendix E, and Appendix F).

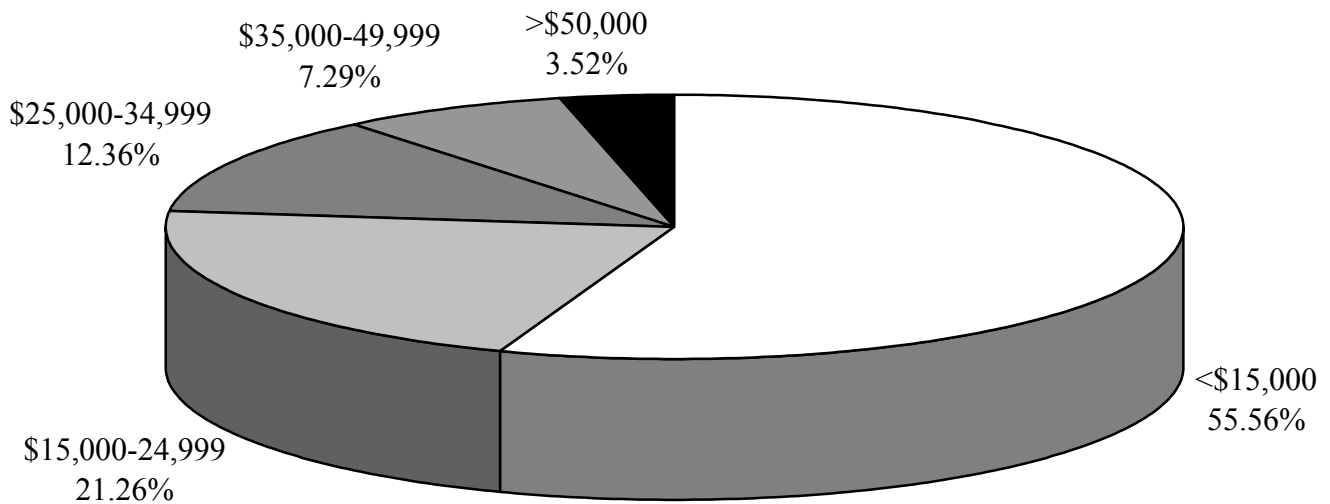

Age of Head of Household



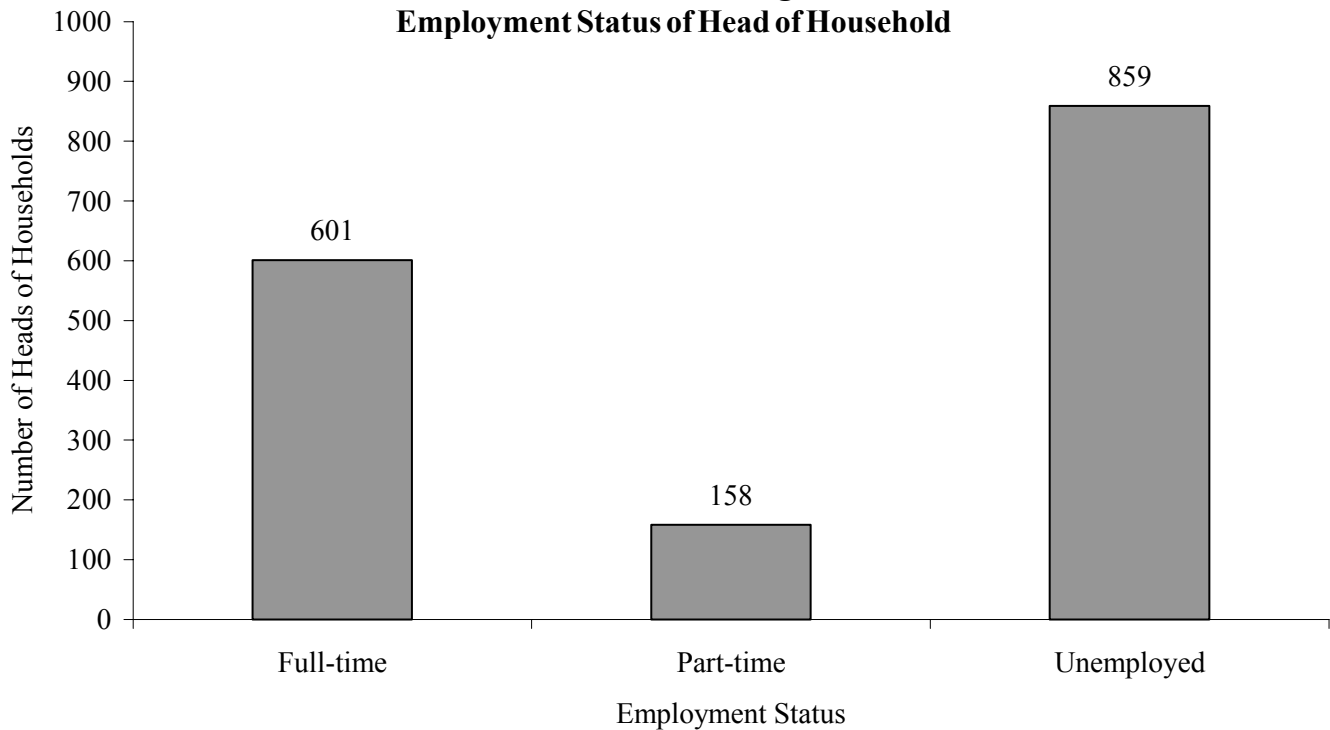

Fifty-six percent of the heads of households earned incomes of less than \$15,000 and 63 percent were either unemployed or only employed part-time (Appendix H and Appendix G).

Almost 67 percent of the 1,618 heads of households required help with parenting skills problems during FY 2003. The next most frequently addressed head of household problem was parent/child conflict at 41 percent (656) followed by communication at 29 percent (477), child neglect at 23 percent (368), and physical abuse at 20 percent (329).

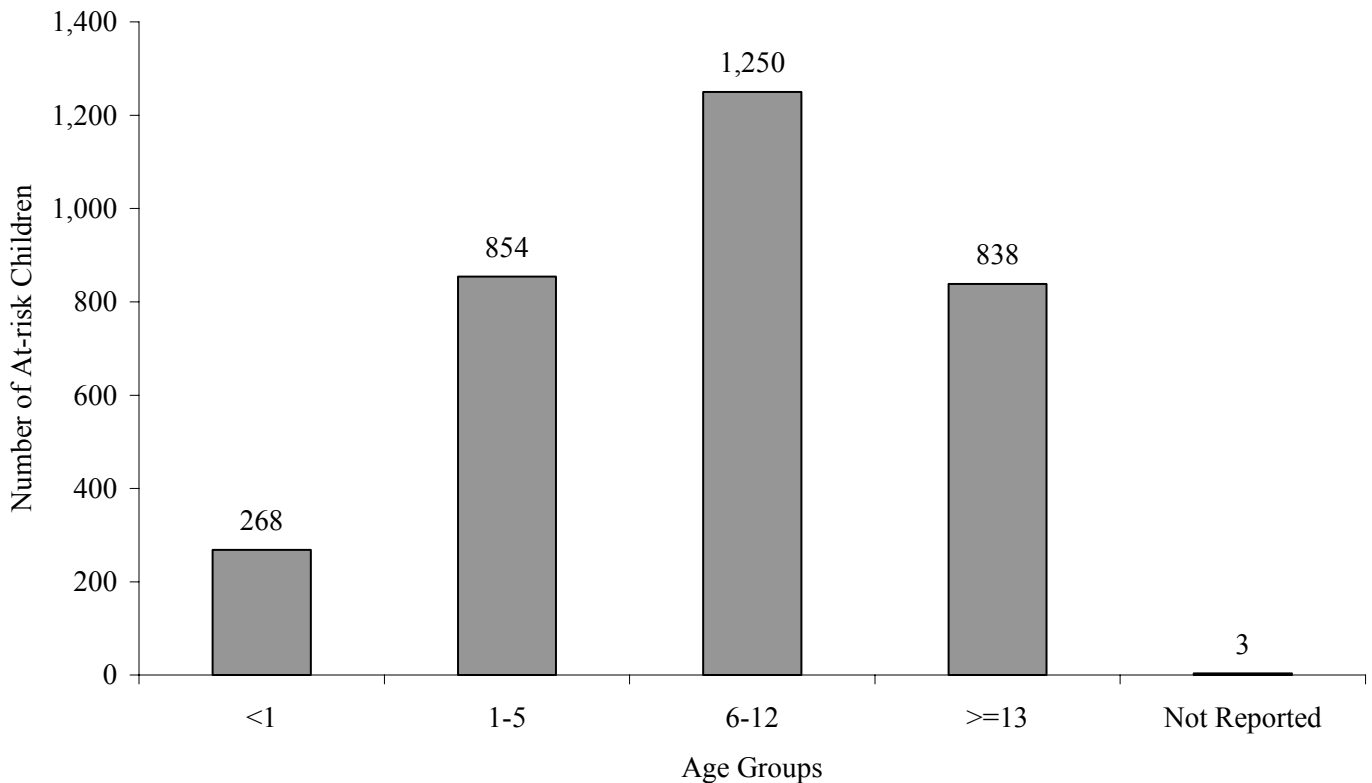

At-risk Children Characteristics of Families Accepted

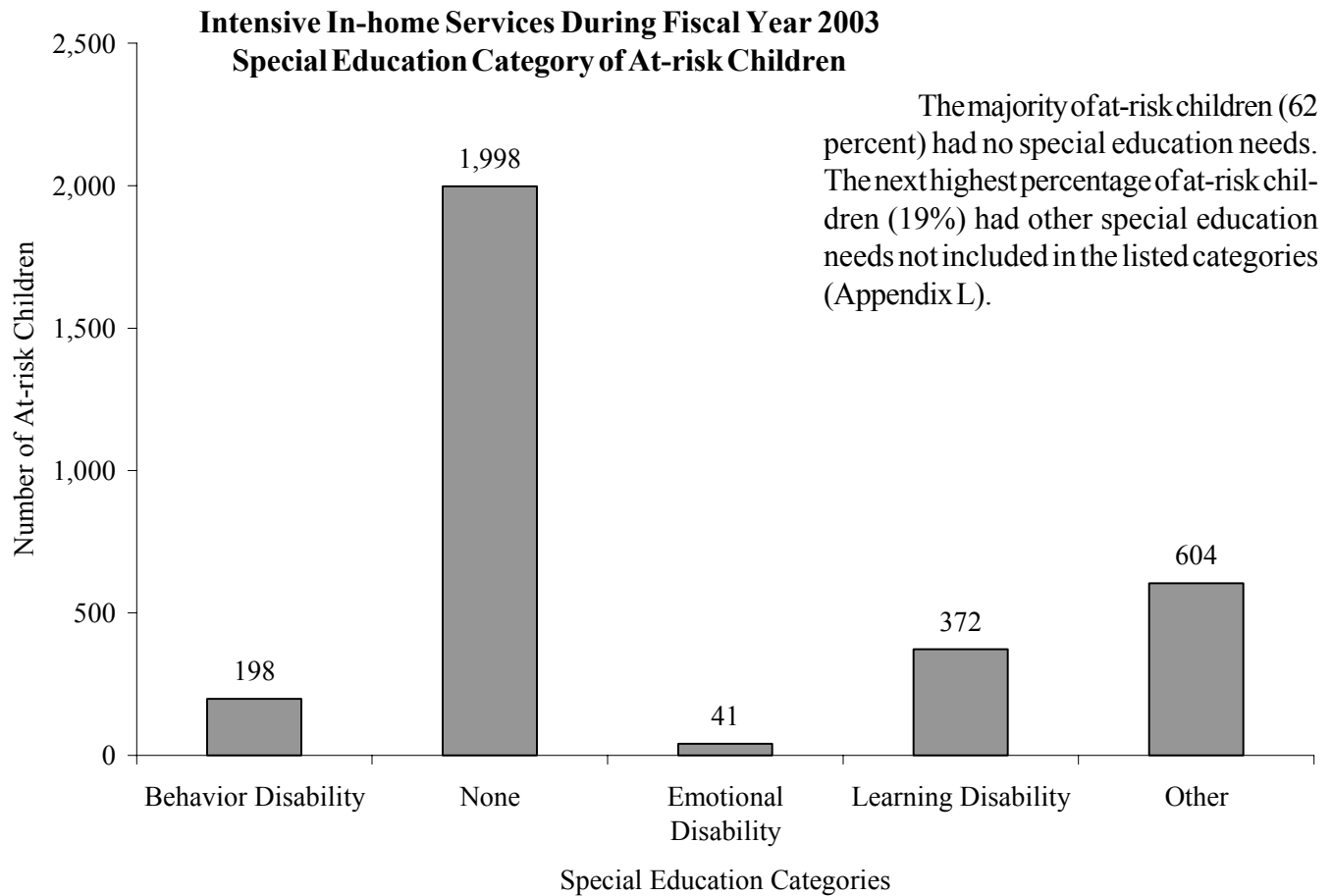
During FY 2003, at-risk children were slightly more likely to be male than female at 51% versus 49%. Sixty-two percent of at-risk children were white, 36% were black and the remaining 2% were other races or not reported (Appendix J and Appendix K). Most at-risk children (39%) were six to twelve years old (Appendix I).

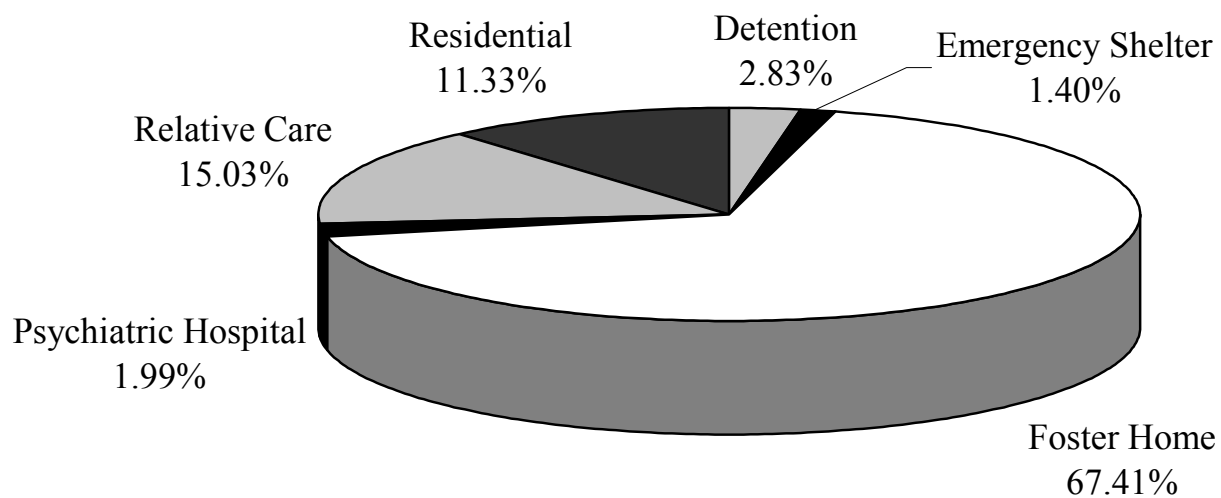
**Intensive In-home Services During Fiscal Year 2003

Sixty-seven percent of the at-risk children avoided placement into foster homes by receiving IIS. Without IIS, 15 percent of the at-risk children would have been placed with relatives, another 11 percent in residential placements, three percent in detention, two percent in psychiatric hospitals and one percent in emergency shelters (Appendix M).

At-risk Children Characteristics of Families Accepted (continued)

Thirty-five percent (1,128) of at-risk children had Parent/Child Conflict issues as the most common problem addressed in IIS during FY 2003. The next most common problems addressed were Parenting Skills Problems at 29 percent (925) and Communication at 23 percent (738).

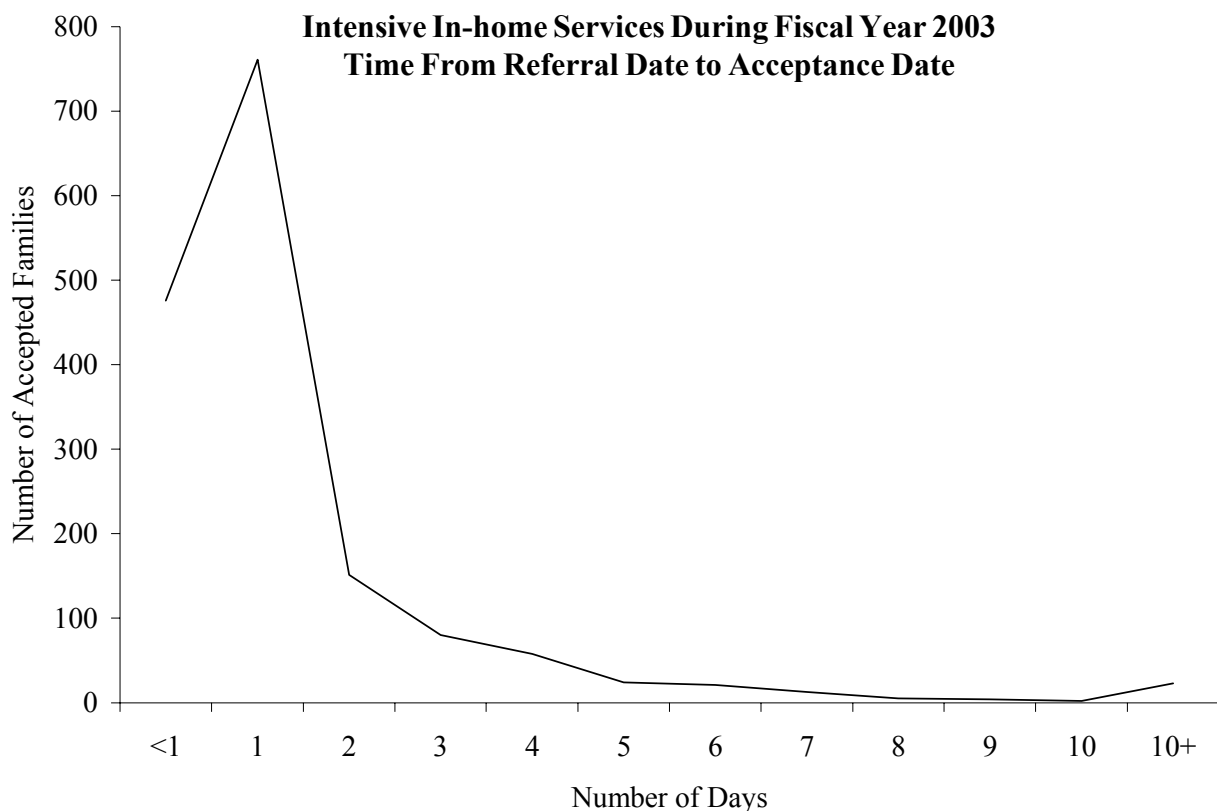
Prior Contacts

Of the 1,618 families accepted into IIS, 899 families had at least one contact with another agency prior to the IIS intervention. Those 899 families had a total of 1,475 prior contacts. Fifty-two percent of the prior contacts were with DFS, followed by 21% with the Juvenile Court.

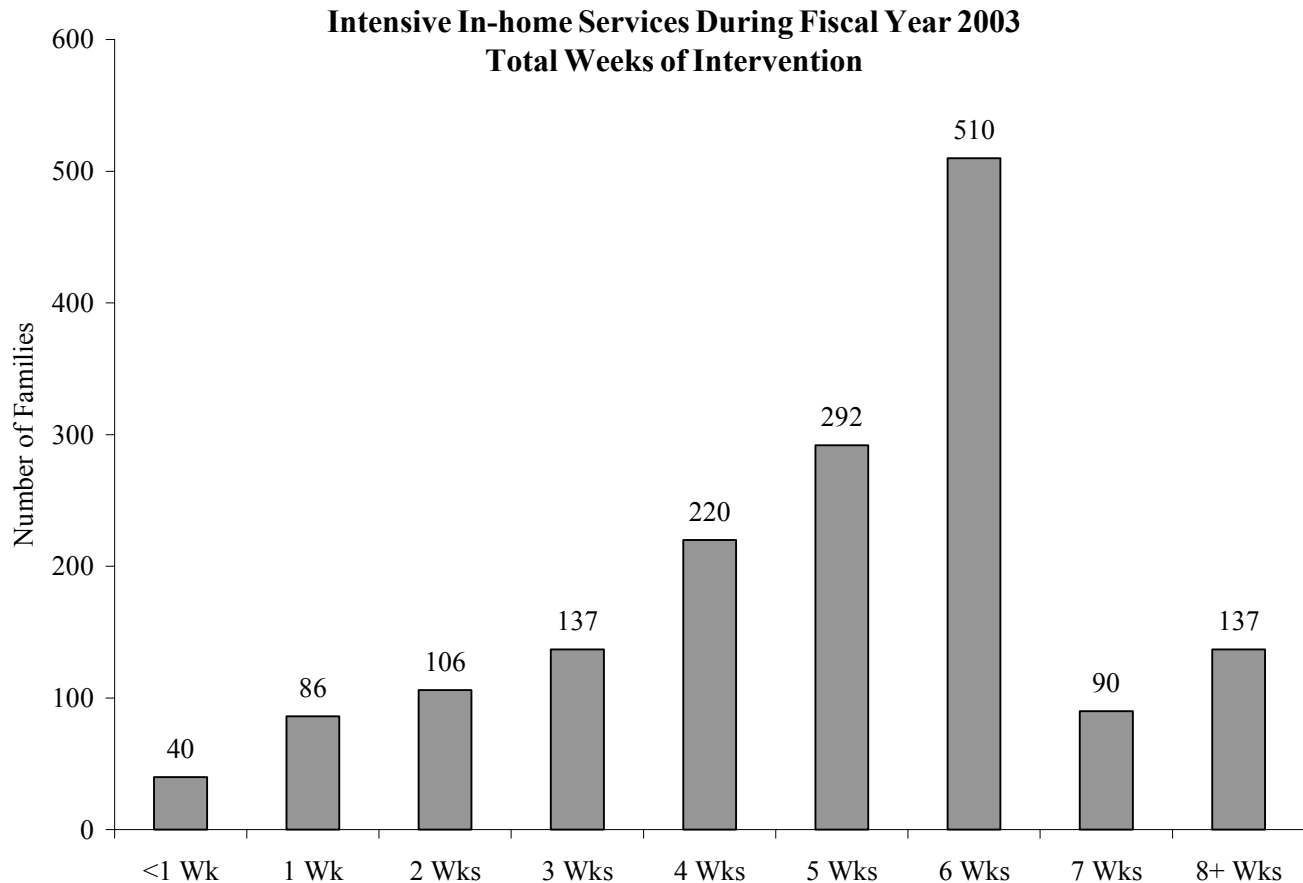
Response Time

A family referred to IIS is first screened to determine the family's acceptance into the program. Once a family is accepted into IIS, an acceptance date is entered into the Intake Tracking System for that family and Intensive In-home Services begin. For the 1,618 families accepted into IIS, the average time between referral date to screen date was 1.45 days and the average time between screen date to acceptance date was 2.8 days. The total time between referral date to acceptance date averaged 1.84 days.



Total Weeks of Intervention

During FY 2003, the majority of families (86 percent) exited IIS within six weeks of acceptance into the program. The average length of intervention was 5.44 weeks.



Families and At-risk Children Exiting

Families and children who leave IIS during the fiscal year are considered to exit in one of the following categories: family intact, family not intact and other. Families are not intact if one of the following occurs: Child Ran Away, Child Moved Out of Home (not placed), Child Living with Relative or Guardian (not Court Ordered), Child Living with Relative or Guardian (Court Ordered), In Foster Home or Group Home, In Residential Treatment, With Division of Youth Services (DYS), In Juvenile Justice and In In-Patient Psychiatric Diversion. Other includes the following: Can't Locate Family, Information Not Available and Other. During FY 2003, 87 percent (1,415) of the 1,633 families and 89 percent (2,852) of 3,203 at-risk children exiting IIS were reported to be in intact families (Appendix N).

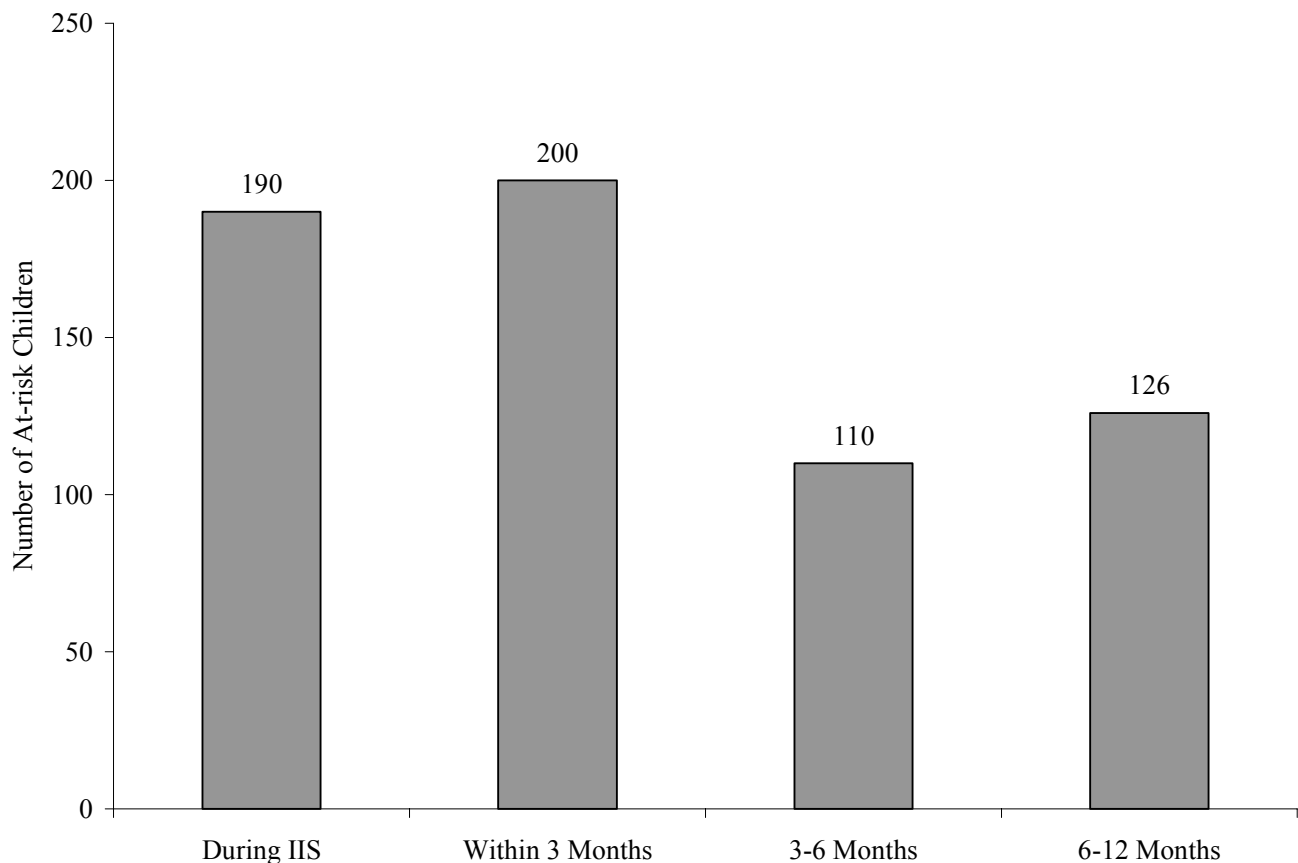
Outcomes

Do families remain safely together after acceptance into the IIS program? Outcome measures of the IIS program include checking to see if a child enters DFS or DYS alternative care or is listed as a victim of a substantiated child abuse/neglect hotline

Children who exited IIS during FY 2002 were checked to see if they had entered DFS or DYS custody or if they were a victim of a substantiated child abuse/neglect hotline during IIS intervention or within 12 months of exiting IIS. FY 2002 exits were used to give all the children exiting enough time to see if the events had occurred.

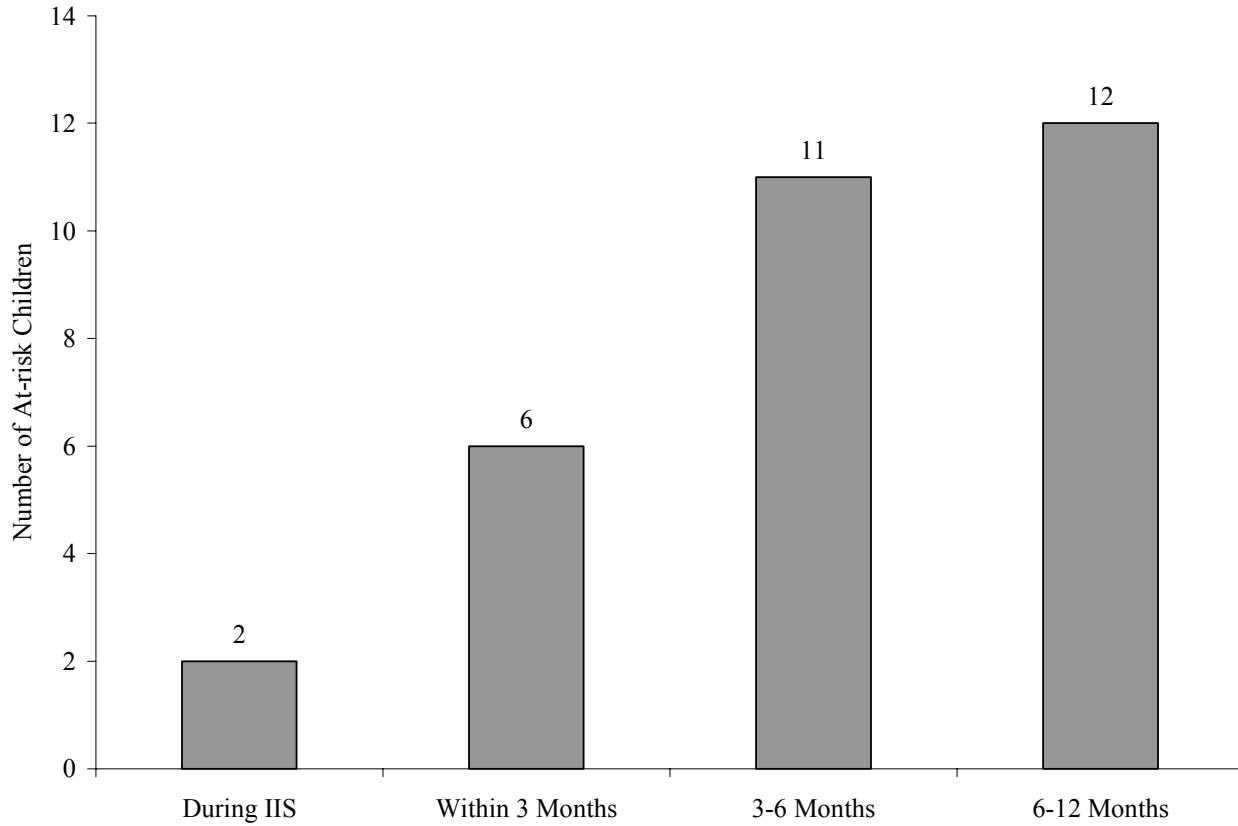
During FY 2002, 3,373 at-risk children exited IIS. Tracking those children during the IIS intervention and for the 12 months following the exit of their IIS intervention, 19% (626) entered DFS custody and one percent (31) entered DYS custody. Twelve percent (414) of the children were victims of substantiated child abuse/neglect.

At-risk Children Who Entered DFS Alternative Care**

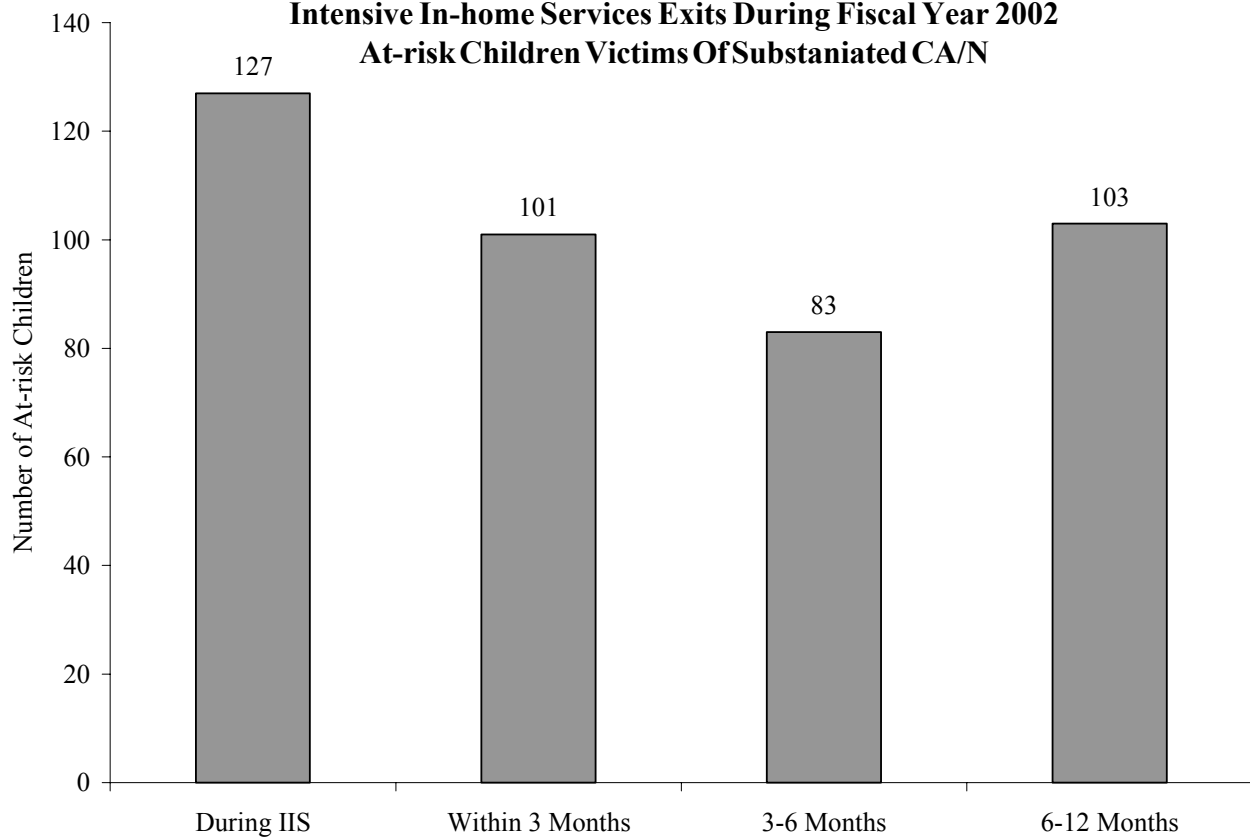
