






Figure 4. Children Served by Provider








Figure 7. Children Served By Region





12-Month Average July 2020 - June 2021









Figure 8. Total Children Served By Age Group










Figure 13. Children Served in Family Home By Age




Figure 14. Children Served in Group Home By Age



Figure 15. Transitional Households by Level June 2021





Figure 16. Transitional Children by Level June 2021





Figure 17. Children Served By Provider Type








Figure 19. Expenditures by Reason for Care


Figure 20. Households by Reason for Care
